Ordinance No. 16-012 proposed to amend the existing zoning code of the City.

The City Clerk read the Planning Commission Report. Upon a motion of Mr. Darius Brown, seconded by Ms. Walsh, the Planning Commission Report was made a part of the record and is on file at the City Clerk's Office and/or the Planning Department. Motion prevailed.

President Gregory: Can we have someone from the Planning Department to come up and present please?

Department of Planning Representative: Good evening. I'm Gwinneth Kaminsky with the Planning Department.

I will be addressing the request by Moat Street LLC for the annexation of a two acre parcel of land located at 3604 Downing Drive, adjacent to the city corporate limits in the County.

There are two action items on Council's agenda this evening which are necessary to implement the proposed annexation.

First, changes to the comprehensive plan for the Price's Run /Riverside /11<sup>th</sup> Street Bridge neighborhoods must be made to show that the annexed territory is being included within city limits, and also to provide the appropriate land use and zoning for that land. These amendments are made by Council resolution.

Second, the actual annexation and rezoning actions must be approved, which includes amending the official building zone and supplemental maps. This is addressed in Ordinance 16-012.

Although these actions are scheduled for separate hearings, in the interest of time I will discuss them both together.

The parcel in question is located in the Downing Industrial park and is zoned for heavy industrial use, which is a county designation. The majority of this park is located within City limits, however, and is zoned M-1 light manufacturing. Downing Drive provides access to this area, and the applicant owns four additional parcels along this right of way, within the city. By annexing the County parcel and rezoning it to M-1, the owner will be able to develop all five parcels under the same set of regulations, for consistency.

The purpose of the annexation is to facilitate redevelopment within the industrial park, which will in turn support business growth and development. To that end, the Office of Economic Development is making targeted investments in this area which are expected to promote the creation of blue collar jobs. They have also engaged a consultant to study the feasibility of improving the Downing Drive right of way, which is currently only partially constructed and is not a thru street.

Next, I'd like to turn your attention to the State's annexation procedures. Wilmington is empowered by the State of Delaware to annex territory into its boundaries, although municipalities with populations greater than 50,000 are subject to more stringent requirements for approval.

This rule only applies to Wilmington at the moment. These annexation requirements are found in Title 22 of the State Code.

These requirements are also embodied in the City's own Annexation Policy and Procedures Checklist, which was adopted into our City Wide Plan of Land Use.

For the Downing Drive annexation, State procedures are being followed, including filing a petition for annexation with both the City and County Clerk offices; conducting public hearings and notifying the Office of State Planning Coordination of the proposed annexation; compliance with the city and state's comprehensive planning processes; rezoning the property as a part of the approval process; and preparing a Municipal Plan of Services report to determine whether the necessary services can be provided to the annexed territory.

In our case, the City is well equipped to serve the new territory because it is a self-sufficient municipality which provides its own police, fire, and emergency medical services; utilities, including water and sewer; and road infrastructure.

Title 22 also requires that annexations meet certain criteria for approval, including being fiscally responsible; being in the best interest of the city; that the target area be a potential growth center; and that the annexation provide long term benefits to the city. The parcel must also be contiguous to the city limits and all of these conditions for approval have been met.

The Planning Commission considered the annexation request at their public hearing held on March 15<sup>th</sup>. At that meeting, the Commission recommended the amendments to the Price's Run/Riverside/11th Street Bridge Comprehensive Development Plan, for the purpose of adding the affected territory to the City corporate limits, and to designate M-1 Light Manufacturing land use and zoning for the site and the 17 maps being amended are attached to your Council resolution.

The Commission also recommended approving the annexation of the territory and rezoning to M-1, and making the necessary revisions to the Official Building Zone Map and supplemental maps and these actions are addressed in Ordinance 16-012, which includes the maps in question.

The next step, if approved by City Council, will be to proceed to New Castle County where similar legislation will be considered by their planning board and Council. And, of course, the mayor and county executive must both be in agreement with the annexation.

In the meantime, the applicant and city staff has been meeting with city and county elected officials, community groups and neighborhood planning councils to discuss the proposal, and we have received a letter of support from the Eastlawn Civic Association.

In summary, the proposal to annex 3604 Downing Drive into the City of Wilmington has met the state and city requirements for annexation, and has been recommended by the City Planning Commission.

I'd be happy to address any questions. Thank you.

President Gregory: Are there any questions from City Council? Anyone in the public want to speak "for" or "against"?

Ms. Walsh: Can I ask one question? I'm sorry. Mr. President?

Mr. President: Ah hum.

Ms. Walsh: Since we do need County Council approval of this, this is very, very rare that we've done something like this because they've always objected to land that we've wanted to get earlier. Were they part of our process at all?

Ms. Kaminsky: Yes. The applicant has met with Council Member Penrose Hollins...

Ms. Walsh: Ok.

Ms. Kaminsky: ...so, there has been discussion also with Tom Gordon at the County.

Ms. Walsh: Ok. That's all I wanted to know. Thank you.

President Gregory: Thank you.

Ms. Kaminsky: Sure.

Upon a motion of Mr. Darius Brown, seconded by Ms. Walsh/Ms. Shabazz, Council returned to Regular Order of Business. Motion prevailed.

WHEREAS, at its meeting on March 15, 2016, the City Planning Commission passed Resolution 3-16, which recommended to City Council that the Price's Run/Riverside/11<sup>th</sup> Street Bridge Comprehensive Development Plan be amended to revise Plan Maps A through Q to include that certain property located at 3604 Downing Drive, Wilmington, Delaware, being New Castle County Tax Parcel No. 06-152.00-003 (the "Property") within the City of Wilmington corporate limits, and to specify light manufacturing land use and zoning for the site as depicted on the maps attached hereto and made a part hereof as Exhibit A through Exhibit Q; and

# FINDINGS SUPPORTING ENACTMENT OF ORDINANCE NO. 16-012

CITY COUNCIL'S FINDINGS SUPPORTING ENACTMENT OF ORDINANCE NO. 16-012, which is an annexation ordinance to add a parcel of land, containing approximately 2.04 acres as illustrated on the maps attached to Ordinance 16-012 and as depicted on the map attached hereto, and to assign a zoning designation of M-1 (light manufacturing) to the annexed parcel of land.

The Council Findings support the assignment of the zoning classification of M-1 (light manufacturing) to the area of the annexation.

# FINDINGS SUPPORTING ENACTMENT OF ORDINANCE NO. 16-012

# Zoning Action:

Assign the zoning classification of M-1 (light manufacturing) to the Area of Annexation, the boundaries of which are described in the maps attached to Ordinance 16-012 and as illustrated on the attached map.

- 1. The proposed zoning action is consistent with the Price's Run/Riverside/11<sup>th</sup> Street Bridge Comprehensive Development Plan, as proposed to be amended, which is being adopted by City Council Resolution contemporaneously herewith.
- 2. The existing land use patterns appear to have been adverse to certain uses and future improvements and the area is more likely to be developed in an appropriate manner if the proposed zoning actions are enacted for uses and purposes within the M-1 zoning classification as set forth in Chapter 48 of the City Code.
- 3. Assigning the zoning designation to the said property will not create any isolated districts, but rather will better relate the property to the nearby areas and future best uses of the property.
- 4. The proposed zoning action will have no negative effect on population density patterns and will not overburden public utilities and facilities.
- 5. The proposed zoning action will have positive, and not adverse, influence on uses in the area, particularly with regard to light manufacturing uses which will promote the growth of blue collar jobs within the City.
- 6. The proposed zoning action will not create or excessively increase traffic congestion or otherwise adversely affect public safety.
- 7. The proposed zoning action will not seriously reduce light and air to adjacent areas, but will be consistent with and complementary to the zoning classifications of nearby zoning districts and the property uses therein.

- 8. The proposed zoning action will not adversely affect property values in the adjacent areas, nor will it be a deterrent to the improvement or redevelopment of adjacent properties, but rather should have a positive effect.
- 9. The proposed zoning action will best serve the public welfare and will not constitute a grant of any special privilege to any individual owner of property.
- 10. The proposed zoning action will not be out of scale but rather will be consistent with the needs and current and future uses of the subject area and the City of Wilmington.
- 11. The proposed zoning action is consistent with the adjacent M-1 zoning.
- 12. The proposed zoning action reduces the higher density and potentially adverse nature of current heavy industrial designation on the adjacent neighborhoods.
- 13. The proposed zoning action adhere to the standards set forth in the applicable provisions of Chapter 48 of the City Code, Title 22 of the Delaware Code, and applicable Delaware case law.

## **CONCLUSION**

This concludes the set of Council's Findings for the property that is subject to the zoning action set forth in Ordinance 16-012 and as illustrated on the maps attached to that ordinance and on the map attached to these findings. The Ordinance incorporates the recommendations of the Planning Commission in its Resolution 03-16 and 04-16 regarding the amended Comprehensive Development Plan for the Price's Run/Riverside/11<sup>th</sup> Street Bridge area and the zoning action as approved by the City Planning Commission. 

## On the question:

Mr. Darius Brown: Yes Mr. President, this Ordinance is being presented by the Administration to Council, which would for a two-year lease agreement between Urban Bike Project of Wilmington for the use of the City-owned property at 301 East 15<sup>th</sup> Street. The monthly lease fee for this agreement is \$500 per month. The Urban Bike Project currently is leasing this property from the City and has been a strong partner throughout the City but particularly in the northeast and eastside throughout its existence.

President Gregory: Declare it adopted. Ms. Shabazz.

Ms. Shabazz: Yes Mr. President, I have an Ordinance to present and call for the third and final reading.

Ms. Shabazz presented and called for the third and final reading <u>Ordinance</u> No. 16-010 (Agenda #4166) entitled:

AN ORDINANCE TO AUTHORIZE AN EXTENSION TO CITY CONTRACT 14045WDPS, FIRE HYDRANT TESTING AND REHABILITATION SERVICES, WITH UTILITY SERVICE CO., INC.

On the question:

Ms. Shabazz: This Ordinance is being presented by the Administration for Council review and approval and authorize through Administration through the Department of Public Works to extend for one additional year, the contract with Utility Services, Inc., for the inspection, water flow testing and rehabilitation of the City's approximately 2,500 fire hydrants. The original contract with USC became effective last March and contained two, one-year contract extension periods.

President Gregory: Did we get how much this cost us to do this in the County? That question was asked of all two or three of the ordinances that are coming up now.

Ms. Shabazz: Did they give that to staff?

President Gregory: We were supposed to get some figures. Did we get them? Did we get them?

Mr. Michael Brown: No.

President Gregory: Can we hold these if you don't mind? There's no urgency for them. We wanted those numbers.

Ms. Shabazz: Yeah, we did – we did want those numbers and it was discussed in committee.

President Gregory: Can we hold these? Can we hold #4166, #4167?

Ms. Shabazz: I have no problem with holding them.

President Gregory: Yeah; we're going to hold #4166 and #4167. So you have #4189?

Ms. Shabazz: That's correct.

President Gregory: This is the issue. We lost a lot of money through the property casualty tax adjustment....

Ms. Walsh: Mr. President, do you want to go out of the question right now?

President Gregory: We're going to go out of the question.

Ms. Walsh: Ok; thank you.

President Gregory: But we're going to hold. We're going to hold these. But yet, we're now servicing their fire hydrants and water lines in the County and presumably the reason why we are getting the money we were getting is because we are providing services out there.

Ms. Shabazz: Correct.

President Gregory: We need to know how much its costing us to go out there and we were promised these numbers. We need the numbers.

Ms. Shabazz: I agree.

President Gregory: Ok; thank you. Thank you for letting me...

Ms. Shabazz: So, on the question.

President Gregory: ...kind of vent and go out of order.

Mr. Michael Brown: They couldn't really hear you. You weren't talking in the mic.

President Gregory: We need the numbers, okay?

Ms. Shabazz: Mr. President, I'd like to hold #4166 and #4167.

Ms. Walsh: Mr. President, I think you actually at this point have to table it because it's already been introduced and the question is called.

President Gregory: Hold on. I can hold it? Alright, we're going to hold #4166...

Ms. Shabazz: ...66 and #4167.

President Gregory: ...#4167. Since I agree with you, I'm going to listen to you this time. You didn't get that? You got that? Thank you; I appreciate that. Okay, we're going to go to #4189.

Note: Ordinance No. 16-010 (Agenda #4166) and Ordinance No. 16-011 (Agenda #4167) were both **HELD** due to not receiving the information requested by President Gregory.

Ms. Shabazz: No. That's a first and second.

Mr. Wright: You still got a - -

President Gregory: The next ordinance is #4189.

Ms. Shabazz: That's correct. Yes sir. Mr. President, I have an Ordinance to present and call for the first and second reading.

Ms. Shabazz presented and called for the first and second reading Ordinance No. 16-019 (Agenda #4189) entitled:

Ms. Shabazz: Last Mr. President, I have a Resolution to present on your behalf.

On behalf of President Gregory, Ms. Shabazz presented <u>Resolution No.</u> 16-027 (Agenda #4191) as follows:

WHEREAS, supporting and facilitating job creation is considered by many to be a vital function of government, particularly at the local level; and WHEREAS, this is especially true in Wilmington, where City officials and leaders work diligently to foster an environment ripe for job creation; and WHEREAS, House Bill No. 283, also known as the Veterans, Skilled Workers, and Community Workforce Act, has been introduced in the Delaware General Assembly and is presently being considered by State lawmakers; and

WHEREAS, the bill would require that, on all State-funded construction, public works or improvement projects, contractors and subcontractors draw 30-percent of their workforce from the Representative District within which the project is located, and 5-percent of their workforce from among eligible Delaware veterans; and

WHEREAS, this legislation is poised to have a significant impact in securing employment for Delawareans throughout the State, and in mobilizing the local community through applicable State-funded projects; and

WHEREAS, the City Council seeks to express its support of this legislation and the promise it shows to help support employment for Wilmingtonians.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that the Council supports House Bill No. 283, and respectfully encourages State representatives throughout Delaware to support the measure – and by extension, the hiring of local residents in Wilmington and beyond to put their skills to work on State-funded construction, public works and improvement projects throughout Delaware.

### On the question:

President Gregory: You can speak to it.

Ms. Shabazz: Ok. This Resolution is being presented by City Council for Council's review and approval. Council would urge the Delaware General Assembly to pass House Bill 283, also known as the Veterans, Skilled Workers and Community Workforce Act. This legislation would require that on all State-funded construction, public works or improvement projects, contractors and sub-contractors draw 30% of the workforce for a particular project from the Representative District within which the project is located and 5% of the workforce from among eligible Delaware veterans.

President Gregory: Mr. Wright.

Mr. Wright: Can I be added as a cosponsor please?

President Gregory: Absolutely. Ms. Dorsey Walker.

Ms. Dorsey Walker: I'd like to be a cosponsor as well please? Thank

you.

President Gregory: Absolutely. Mr. Williams.

Mr. Williams: Likewise. Thank you.

President Gregory: Mr. Brown.

Mr. Brown: Likewise.

Mrs. Seijo (City Clerk): M. Brown or?

Mr. Michael Brown: Michael Brown, Sr.

President Gregory: Mr. Chukwuocha.

Mr. Chukwuocha: As well Mr. President; thank you sir.

President Gregory: The Clerk will call the roll.

Upon a motion of Ms. Shabazz, seconded by Mr. Williams, the Aforementioned Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, Michael Brown, Walsh and Wright, and Council President Gregory. President Gregory: Declare it adopted. Mr. Prado

Mr. Prado: Nothing tonight Mr. President.

President Gregory: Ms. Dorsey Walker.

Ms. Dorsey Walker: Mr. President, I have an Ordinance to present on behalf of you and I and call for the first and second reading.

President Gregory: Thank you.

On behalf of President Gregory, Ms. Dorsey Walker presented and called for the first and second reading <u>Ordinance No. 16-021</u> (Agenda #4192) entitled:

AN ORDINANCE TO CLOSE A PORTION OF LIBERTY STREET

The aforementioned Ordinance was given two separate readings by title only and upon a motion of Ms. Dorsey Walker, seconded by Ms. Walsh, the Ordinance was received, recorded and referred to the Finance Committee. Motion prevailed.

President Gregory: Mr. Williams

Mr. Williams: Mr. President, I have an Ordinance to call for the third and final reading.

Mr. Williams presented and called for the third and final reading Ordinance No. 15-039 (Agenda #4096) entitled:

AN ORDINANCE TO AMEND CHAPTER 40 OF THE CITY CODE REGARDING EMPLOYEES' DISCLOSURE OF DELINQUENT PROPERTY TAXES, WATER/SEWER FEES, LICENSES AND INSPECTIONS FEES, FEES RELATED TO PARKING OR RED LIGHT VIOLATIONS, OR OTHER OBLIGATIONS OWED TO THE CITY

Mr. Williams: Mr. President, I have a Substitute to present in lieu of that

ordinance:

AN ORDINANCE TO AMEND CHAPTER 40 OF THE CITY CODE REGARDING ELECTED AND APPOINTED CITY OFFICIALS' DISCLOSURE OF DELINQUENT PROPERTY TAXES, WATER/SEWER FEES, LICENSES AND INSPECTIONS FEES, FEES RELATED TO PARKING OR RED LIGHT VIOLATIONS, OR OTHER OBLIGATIONS OWED TO THE CITY

#### On the question:

Mr. Williams: Mr. President, this Ordinance is being presented tonight to Council for its review and approval. If approved, Council would be authorizing amendments to Chapter 40 of the City Code that would require elected and appointed City employees to report annually any outstanding delinquencies to the City in taxes or fees. Specifically, this Ordinance would require all elected and appointed City officials to file an annual declaration of delinquent obligations with the City's Human Resources Department by the last day of January. Elected and appointed employees would have to declare if they are delinquent on property taxes, water/sewer fees, license and inspections fees, parking or red light fines or fees, or any other obligation owed to the City. Failure to comply with the law would be a Class A misdemeanor offense under a State law that prohibits individuals from making a false written statement. Maximum violations of the law are punishable by up to one year of incarceration and a fine of up to \$2,300, restitution or other conditions as a court may deem appropriate.

President Gregory: Mr. Brown.

Mr. Michael Brown: Thank you Mr. President. Originally, I said I wasn't going to support this thing but – but something fell out of the sky and hit me in the head and I woke up and said, well you're not going to be here next year. So, it really doesn't affect you but – than again, I look at it this way. With all the violations and the penalties that was read off, we have folks violating stuff now that should be aggressively going after and we don't. And, we have possibly – or, we know we got a new administration coming in on Council side and the President would have the obligation or the responsibilities would lay on he or she to appoint its staff members and that President or

that individual in all essence should be the one that do the vetting and as well as – as long as the policies that are on the books right now, residency and all these other things that are – that are adhered to. But I, you know, like I said, you know, it takes away in my opinion, even with the next Mayor that's going to come over on the other side, he or the next Mayor have an opportunity to add appointees in different directorships and that Mayor, should – when he vets' them before he hires them, along with the personnel policy that says, you know, you – you have to live in the City six (6) months after hire and in order to get an extension you have to go to the Board of Residency to get a six (6) months extension approved by the Mayor and that Board and then all the other policies that follow within. But again, I hesitated; I said I wasn't going to vote for it but it's all right with me tonight. I'm good. I'm going to ahead and let my vote be a Yea vote because guess what, December 31<sup>st</sup> I won't be here after that. So, thank you.

President Gregory: Real quick. I was not in favor in the Ordinance when it included employees, which would be other than appointed and elected officials. I'm ok with appointed and elected officials and I told Mr. Williams that I would cosponsor it with him if he made – took out regular employees and I think that's appropriate. So, that's why I'm on it as a cosponsor. Also, I was concern about the misdemeanor aspect of it but in order to commit a misdemeanor, false statement has to be an intentional act. Not a reckless act or a negligent act or inadvertence. It's got to be intentional. My concern was having six (6) children and they all can drive now and they drive my car and they don't always tell me when they get a ticket and I find out when I get the letter in the mail and there was some concern there. But again, that wouldn't be an intentional act. That would be an inadvertent act. So, it has to be intentional. But - and also, I want to make sure that the misdemeanor standard was the same for residency and for the conflict statements that we submit and I'm told that it is. And, as Mr. Brown noted, we don't enforce those too, so, I assume there be — we'll do something with this. So, with that I think it's a good piece of legislation. The Clerk will call the roll.

Upon a motion of Mr. Williams, seconded by Ms. Walsh, the aforementioned **Substitute** Ordinance was read for the third and final time and was adopted by title and section recurring to the Enacting Clause and was passed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, Michael Brown, Walsh and Wright, and Council President Gregory. Total, twelve. Nays, none. Absent, Council Member Cabrera. Total, one.

President Gregory: Declare it adopted. Mr. Williams.

Mr. Williams: Mr. President, I have a Resolution to present.

Mr. Williams presented Resolution No. 16-028 (Agenda #4193) as

follows:

WHEREAS, Delaware, like many other states, has witnessed a dramatic increase in the abuse of heroin and opioids in recent years, and as a result has experienced an increase in the number of patients overdosing on these substances; and

WHEREAS, medical professionals promote the use of the life-saving drug Naloxone – frequently referred to as Narcan – as an emergency medication administered to an individual suffering an overdose, and one that has repeatedly been shown to counteract the effects of an opioid-related overdose; and

WHEREAS, while Narcan has long been carried by paramedics and stocked in hospitals, an increasing number of law enforcement agencies across the country are beginning to train officers to carry the emergency medication; and

WHEREAS, police departments have reported tremendous success, with many officers deploying Narcan and saving patients in the initial days of carrying the medication; and

WHEREAS, a policy requiring police officers to carry Narcan while on duty offers tremendous promise to further enhance the life-saving capacity of law enforcement officials in Wilmington.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that the Council respectfully encourages leaders of the Wilmington Police Department to provide training and certify officers to carry Narcan while on duty. It is the hope of the Council that continued efforts to identify and implement such tools and programming will help to combat the increase in heroin and opioid overdoses experienced by those in Wilmington.

# On the question:

Mr. Williams: Mr. President, if approved, Council would be requesting that the Administration require that the Wilmington Police Department to provide training and certification for police officers to carry and administer Narcan, an emergency medication that has been shown to counteract the effects of opioid-related drug overdoses.

President Gregory: Mr. Brown.

Mr. Michael Brown: Yes Mr. President, if all Council Members would bear with me. If you know I had inserted the – an old ordinance – I mean a Resolution from September – that was dated September 18, 2014 sponsored by myself and cosponsored by Mr. Williams in referenced to Narcan. I also attached a response from the Chief of Police that I want to make sure that back in – back than we had had a public safety hearing and officially the question was asked at the meeting, do your department need Narcan? And, he said "no" then and he says "no" now. Well, after hearing – listen, I know - something – something – here recently – here recently something's been falling hitting me on my head. After speaking to two of the constituents and hearing them speak and then when one of the constituent came over to me and I reflected – I reflected on a conversation and I promise that I had made to my mother, God bless her soul, I grew up in New York City watching heroin addicts shoot heroin when I was ten, eleven, twelve years old – look out the window and they were in the alley I used threw things down at

them, try to chase them away, I watched them OD in the alley, I've rush down them and put them under the water hydrant and walked around the block with friends and try to revive them. They didn't this kind of stuff. And then after speaking with them, I sat here and I kept reflecting on my promise that I made to my mother that I would never shoot drugs. And, I frown when they put a needle in my arm, I chinch. And so, and so - I came to fight this tonight but I changed my mind. Anything that we can do to encourage the Wilmington Police Department to change or the Chief of Police to change his mind and his decision - in the meantime also be more educated and telling folks that the pharmacy - that the State has passed a law and the pharmacy would be selling Narcan real, real soon at a possibly \$40 a pop. So, I'm going to vote for this tonight and it's only in good heart that I do not want to tie up this piece legislation through a debate and - and or an argument. But this is the final thing I want to say, when they - the two sponsors of this bills was doing this, I thought it would be just as courteous – we get on the Mayor's Office for not talking to us and not sharing with us – some of us in here anyway, let me take that back. Some of us do. And, I just thought it would be nice if someone would have shared this with Public Safety Chair due to the fact that we had already put this piece legislation out there. Other than that Mr. President, I'm going to support this tonight.

President Gregory: Mr. Congo.

Mr. Congo: Yes thank you. Do we know why the Police Department is hesitant to do this?

President Gregory: I can't speak to it.

Mr. Congo: Does anyone know? Has anyone heard...?

President Gregory: I don't know.

Mr. Williams: It's never been offered.

President Gregory: I don't know why - other than offered. I do not know why - what the policy reason is for the police department to not want to do this. But the letter that I saw that Mr. Cummings sent said that - read that letter...

Mr. Michael Brown: Yes Mr. President...

President Gregory: ...that would give you the reason why.

Mr. Williams: It's says the paramedics have it.

President Gregory: Because the paramedics have it. That's the why. That's the reason.

Mr. Congo: It doesn't make sense.

President Gregory: That's the stated, the most officially stated reason on record that we have.

Mr. Michael Brown: I can also...I'm sorry.

President Gregory: Just a minute.

Mr. Congo: I guess I say that because we have way more overdose deaths than we do homicides and it seems like anything that we can do to, you know, to bring that number down, it's just a no brainer. But, I guess I would have to have that kind of dialogue with Chief and some other people from the Police Department.

President Gregory: Mr. Brown.

Mr. Michael Brown: I had a couple of conversations with him Councilman and Councilpersons. Especially back when we had the committee meeting and afterwards I said, you're sure you do not – you don't want this? And, he told me – he shared with me that one of the reasons is that his folks don't always get there on first call – first roll. It's usually paramedics and/or the Fire Department. So, that was one of his reasons. It's not that there wasn't any funds out there to get this but he – that was the reason he gave me than and it was the reason he gave about two (2) months ago.

President Gregory: Mr. Williams.

Mr. Williams: Thank you Mr. President. Clearly there's about two thousand doses of this that's available for law enforcement usage. We had some dialogue over the fact that the Wilmington Police did not want a homicide unit. We had a long dialogue about that. Now, we have a homicide unit and look how successful they are. I'm going to read a real quick letter here: Wilmington Police Department, Wilmington Police officers responded and saved two lives. Wilmington responded to two heroin overdoses last night and the early morning hours, one of the overdose victims was saved, the other one was not. The first responder happened about 9:32, the officers were called to a residence in reference to a male subject to a possible overdose – got there - it was too late. The subject was DOA. The second incident occurred at approximately 12:58. They were called to a 25 year old female who was unresponsive, the officers located the victim on the floor, she was not breathing, had no pulse, they administered a dose of Naloxone in the victim's leg and her pulse returned but it was weak. Another dose administered in the opposite leg, her pulse was than strong, she began breathing on her own. That happened in Wilmington – Wilmington, North Carolina. There's no reason why that can't happen here in Wilmington, Delaware. The reasoning that the paramedics are the first ones on scene, I'll tell you it's completely a myth. Wilmington Police officers by very nature, check out suspicious vehicles parked down alleyways, parked in a dark park, parked behind buildings, this is where heroin addicts like to go and use their wares. So

the officers are usually the first ones upon that vehicle when somebody is not responsive. The immediate administration of Naloxone has immediate impact. It won't affect any other organ of the body. It would only affect the opioid. The fact that the paramedics are coming, we've heard in the past, you know, as one of the person that came here earlier and said they came upon a subject they had to standby and wait for the paramedics to get there. It just – it doesn't make sense. With that I just ask you to call for the vote.

President Gregory: I'm not going to do that right now. Ms. Dorsey Walker.

Ms. Dorsey Walker: Thank you Mr. President. Just very quickly; I'd like to address Councilman Michael Brown's concern –

Mr. Michael Brown: Sr.

Ms. Dorsey Walker: Excuse me; Michael A. Brown, Sr.'s concern. We – this piece of legislation – well, this Resolution actually went through the Health, Aging & Disabilities Committee and we made sure we – the members of the Committee – made sure that all members of Council were notified of what was going to be on the agenda, so, just wanted to ensure that he was aware of that.

President Gregory: Mr. Humes, can you stay till the end of the meeting, I want to talk to you and the two young ladies who are with you? I happened to kind of casually walk that way after they spoke, not for the purpose of talking to them necessarily but I told them that Mike Brown was approachable; I told them that the legislation had some challenges and I said, you could go talk to him he's approachable. They said a lot of nice things about him also and that you should talk to him. I think that this is democracy at work; constituents were heard and were listened to, you went and lobbied him one on one – I saw you over there and you got him to change his mind about challenging this and that's a good thing. So, folks should come in and talk to us; they should lobby us; they should voice their opinion because it does work. Even if we don't agree with you, it does work. So, thank you very much but I want chat with you if you don't mind. If that - we'll call – I'm sorry Ms. Walsh.

Ms. Walsh: All I wanted to comment Mr. President was the Wilmington Police should have this. Our Police Chiefs for some reason have always been twenty-five years behind what is necessary some times. It's just not one of those little toys that someone can play with all the time. And, you know, this doesn't become a problem in our country until the middle class and the upper middle class are hit and they got hit with a sledge hammer. So, I'm glad to see it's getting the attention that it needs.

President Gregory: Thank you. The Clerk will call the roll.

Upon a motion of Mr. Williams, seconded by Ms. Walsh, the aforementioned Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, Michael Brown, Walsh and Wright, and Council President Gregory. Total, twelve. Nays, none. Absent, Council Member Cabrera. Total, one.

President Gregory: Declare it adopted.

Mr. Williams: Thank you.

President Gregory: Mr. Freel.

Mr. Freel: Yes sir. I have one for third and final, two for first and second and one Resolution.

#### On the question:

Mr. Freel: Yes Mr. President, this allows the Administration to enter a three-year contract with Belfint, Lyons & Shuman Public Accounts to both audit our Comprehensive Annual Financial Reports and the Federal Funds that we receive ever year. The good thing about the contract is it sets its fee at 185 and that's where it stays for all three-years.

President Gregory: Thank you. The Clerk will call the roll.

WHEREAS, pursuant to Senate Bill 160 (the Fiscal Year 2016 Bond and Capital Improvements Act), the Delaware General Assembly has appropriated \$750,000.00 to the City of Wilmington for the Real Time Crime Center and \$500,000.00 to the City of Wilmington for park improvements; and

WHEREAS, the Chief of Police has recommended that City Council approve the City's acceptance of the State appropriated funds for the Real Time Crime Center; and

WHEREAS, the Department of Planning and Development has recommended that City Council approve the City's acceptance of the State appropriated funds for the park improvements; and

WHEREAS, Council deems it necessary and appropriate to authorize the Wilmington Police Department to accept the appropriated State funds and proceed with the implementation of the Real Time Crime Center; and

WHEREAS, Council deems it necessary and appropriate to authorize the Department of Planning and Development to accept the appropriated State funds and proceed with the park improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington Police Department is hereby authorized to accept the \$750,000.00 appropriated by the Delaware General Assembly pursuant to Senate Bill 160 (the Fiscal Year 2016 Bond and Capital Improvements Act) and take all necessary actions to accept the appropriated funds and implement the Real Time Crime Center.

**BE IT FURTHER RESOLVED** that the Department of Planning and Development is hereby authorized to accept the \$500,000.00 appropriated by the Delaware General Assembly pursuant to Senate Bill 160 (the Fiscal Year 2016 Bond and Capital Improvements Act) and to take all necessary actions to accept the appropriated funds and proceed with the park improvements.

On the question:

Mr. Freel: Yes Mr. President, the Bond Bill that was passed last – I guess, June 30<sup>th</sup>, had two appropriations in there for the City of Wilmington and one was for \$750,000 for a Real Time Crime Center and the other one was \$500,000 for the City of Wilmington park improvements and this just okay's the acceptance of those grants.

President Gregory: The Clerk will call the roll.

Upon a motion of Mr. Freel, seconded by Ms. Walsh, the aforementioned Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, Michael Brown, Walsh and Wright, and Council President Gregory. AN ORDINANCE TO AUTHORIZE AN INSTALLMENT PAYMENT AGREEMENT AND A SECURITY AGREEMENT WITH VAR RESOURCES, LLC, D/B/A VAR TECHNOLOGY FINANCE, TO FINANCE THE PROCUREMENT OF CERTAIN COMPUTER HARDWARE AND SOFTWARE

WHEREAS, pursuant to Title 22, Section 811 of the Delaware Code, a municipal corporation's home rule charter may be amended by act of the Delaware General Assembly passed with the concurrence of two-thirds of all members elected to each House thereof; and

WHEREAS, the City of Wilmington, upon the recommendation of the Department of Finance, desires to amend Section 8-200 of the City Charter relating to contracts and procurement requirements, in order to improve the City's procurement procedures, increase public access to City contracting opportunities through internet

advertising, and to authorize the City's participation in cooperative purchasing agreements, as more particularly set forth in the proposed "House Bill," a copy of which is attached as Exhibit "A" hereto and incorporated by reference herein.

NOW, THEREFORE, the Mayor and the Council of the City of Wilmington respectfully request the members of the Delaware General Assembly to amend Section 8-200 of the City Charter as provided in Exhibit "A," a copy of which is attached hereto.

On the question:

Mr. Freel: Would you like to speak on this sir?

President Gregory: You can if you want to.

Mr. Freel: It basically does two things, it increases the opportunities for public access to the procurement process here in the City of Wilmington and it also gives us the ability to enter into cooperative purchasing agreement with other public entities I think within or with outside the State.

President Gregory: The Clerk will call the roll.

Upon a motion of Mr. Freel, seconded by Mr. Williams/Ms. Walsh, the aforementioned Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, Michael Brown, Walsh and Wright, and Council President Gregory. Total, twelve. Nays, none. Absent, Council Member Cabrera. Total, one.
