President Gregory: Declare it adopted. Mr. Darius Brown.

Mr. Darius Brown: Yes Mr. President, I have two Resolutions and an Ordinance.

Mr. Darius Brown presented <u>Resolution No. 16-006</u> (Agenda #4157) as follows:

WHEREAS, by its Ordinance No. 97-051, amending Section 2-363 of the City Code, the City Council deemed it necessary and proper to specify the requirements for review and approval of City-sponsored grant applications and proposals, including a requirement for City Council approval by resolution; and

WHEREAS, the City of Wilmington Department of Real Estate and Housing, seeks to apply for the City, or an area within the City, to be determined to be a "Promise Zone" by the United State Department of Housing and Urban Development; and

WHEREAS, in his 2013 State of the Union Address, President Barack Obama announced an initiative to designate a number of high-poverty urban, rural and tribal communities as "Promise Zones", where the federal government will partner with and invest in communities to create jobs, leverage private investment, increase economic activity, expand educational opportunities, and reduce violent crime; and

WHEREAS, communities compete for the Promise Zone designation in an application process, demonstrating the strength and effectiveness of their local partners' commitment. Each designated Promise Zone will be asked to identify outcomes they will pursue to revitalize their communities, develop a strategy supporting those outcomes, and realign resources accordingly; and

WHEREAS, the Promise Zone designation partners the federal government with local leaders who are addressing multiple community revitalization challenges in a collaborative way and have demonstrated a commitment to results; and

WHEREAS, Promise Zones will be assigned Federal staff to help navigate the array of Federal assistance and programs already available to them. In addition, Promise Zones will receive preference for certain competitive Federal grant programs and technical assistance; and

WHEREAS, subject to enactment by the United States Congress, businesses investing in Promise Zones or hiring residents of Promise Zones will be eligible to receive tax incentives. This package of assistance is intended to help local leaders accelerate efforts to revitalize their communities; and

WHEREAS, the Promise Zone designation will last for a term of 10

years.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF

THE CITY OF WILMINGTON that the Department of Real Estate and Housing is hereby authorized to apply, or to retain the assistance of professionals familiar with the application process to aid the City, or a part thereof, to be designated a "Promise Zone" by the U.S. Department of Housing and Urban Development so that if such a Promise Zone is designated, the Department of Real Estate and Housing may then apply for further economic assistance consistent with the Promise Zone program.

On the question:

Mr. Darius Brown: Yes Mr. President, this Resolution authorizes the City's Department of Real Estate and Housing to move forward with their application to the U.S. Department of Housing and Urban Development for Promise Zone designation.

Ms. Shabazz: Mr. President.

President Gregory: I'm sorry, Ms. Shabazz.

Ms. Shabazz: Thank you Mr. President. I'd to be put on as a co-sponsor if I may.

President Gregory: So noted. The Clerk will call the roll.

President Gregory: Very briefly, what this does, we have an informal Capital Review Committee – the folks who are named in this in the Section 2-150.76 are the persons or by designee who sit on that Committee. This is to cause that Capital Review Committee to be at least quarterly and to issue a written report, which is a practice but it's not mandated and we have not had that many over the last three years. We want to get some discipline in the process so we'll know how much money we have – we have in the Capital Bond ordinances. Any other comments? Mr. Brown.

Mr. Darius Brown: Thank you Mr. President, speaking as a co-sponsor and in support of the Ordinance that also I want to stress the importance of our capital projects and the importance of investing in our neighborhoods. And, so through these

projects we're able to do many improvements within neighborhoods whether it's infrastructure, investments and our roads; whether it's our water and sewer or even in our parks system that provides many amenities and activities for our young people. So, I know coming on Council there's several projects that were funded that have not been enacted upon and I believe this is a great tool for us to establish some accountability and project management in regards to our capital program.

And, the contract total is \$3 million and it has two, one-year extensions, which is of course at the sole discretion of the City subject to an escalating cause not to exceed to 2 % of the original contract. It was awarded through a bidding – public bidding process. The Brandywine Construction did meet all of the qualifications with the necessary apprenticeship program and also the use of the DBE's.

President Gregory: What this does is folks get fine and if you're at a threshold \$200 or five (5) or more tickets than you move into where you're eligible for a boot. However, with the ticket that meets the threshold, there's an appeal process and what this says is that until the appeal process runs than that can't – that time does not count towards the boot. So, you let the person see if they're going to appeal or not. If they're not going to appeal than of course they become boot eligible. If they appeal than you have to wait until that process runs before you stack this ticket on it.

Ms. Walsh: I have a question.

President Gregory: Ms. Walsh.

Ms. Walsh: Is this a big problem now?

President Gregory: Yes.

Ms. Shabazz: What she say?

Ms. Walsh: Why wouldn't they be logical that until their time is out, it doesn't even exist really?

Ms. Cabrera: Yes Mr. President, I have an Ordinance and a Resolution. I have an Ordinance to present and call for the third and final reading.

Ms. Cabrera presented and called for the third and final reading <u>Ordinance</u> No. 16-007 (Agenda #4153) entitled:

AN ORDINANCE TO AMEND CHAPTER 4 OF THE CITY CODE REGARDING AMENDMENTS TO THE INTERNATIONAL MECHANICAL CODE OF 2012

On the question:

Ms. Cabrera: This Ordinance is being presented by the Administration for City Council's review and approval. Council would be authorizing an amendment to the City Code, Chapter 4 Section 4-81, to correct errors that were intended to be part of the original amendments to the International Mechanical Code of 2012. Specifically, the Ordinance would remove a duplicate provision related to return air in commercial or residential buildings and make minor modifications to the remaining provision. This was an oversite and as discussed in Committee it was overlooked as that document is about an inch in a half thick when the changes were made with the Mechanical Code of 2012.

President Gregory: Mr. Brown.

Mr. Darius Brown: Thank you Mr. President. I'm going to support this Ordinance but I would ask the Chair and also the Commissioner of L&I to have a more thorough review of the International Code. There's many other pieces that were adopted two (2) years ago that as – I have conversations with developers in the City that become challenging.

President Gregory: Thank you. The Clerk will call the roll.

Upon a motion of Ms. Cabrera, seconded by Mr. Williams/Ms. Walsh, the aforementioned Ordinance was read for the third and final time and was adopted by title and section recurring the Enacting Clause and was passed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, Michael Brown, Cabrera, Walsh and Wright, and Council President Gregory. Total, thirteen. Nays, none.

President Gregory: Declare it adopted.

Ms. Cabrera: Mr. President, I have a Resolution to present.

Ms. Cabrera presented Resolution No. 16-008 (Agenda #4161) as follows:

WHEREAS, in June 2015, Puerto Rico's Governor Alejandro Garcia Padilla declared the Commonwealth's \$72 billion dollar debt "not payable" and the government effectively ran out of cash to continue operating; and

WHEREAS, this economic crisis has forced a second "Great Migration" much like after World War II, with more than 250,000 Puerto Ricans leaving the island since 2010; and

WHEREAS, Puerto Rico has taken extraordinary measures to address the situation, including shuttering more than 100 public schools, delaying tax refunds, increasing the retirement age, borrowing from the worker's compensation fund, withholding holiday bonuses, and increasing the local sales tax to a national high of 11.5%; and

WHEREAS, the Federal Government must take strong action to stabilize Puerto Rico and help it restructure the debt by incorporating bankruptcy and debt restructuring protections; and

WHEREAS, the Federal Government must grant Puerto Rico the right to declare for Chapter 9 bankruptcy; eliminate the annual Medicaid/ *Mi Salud* funding cap, and institute tax policies that foster economically diverse and living wage job creation, which will create sustainable growth; and

WHEREAS, the Earned Income Tax Credit is the United States' largest anti-poverty cash assistance program as it increases the ability of workers in low-paying jobs to support themselves and their families. However, the credit does not apply to Puerto Rico; and

WHEREAS, the Child Tax Credit provides substantial tax relief for families with children but applies in limited fashion in Puerto Rico where only families with three or more children are eligible for the tax credit refund; and

WHEREAS, prior to 1985, Puerto Rico had the ability to file for Chapter 9 bankruptcy relief, which was later taken from the territory, thereby limiting its ability to restructure its debts on its own; and

WHEREAS, in October of 2015, over 400 Puerto Rican elected officials and community leaders, representing many different organizations nationwide, convened in Orlando, Florida to discuss the fiscal crisis and a national call was done to establish "Unidos Para Puerto Rico", which unites the Puerto Rican Diaspora and the coalition of

Puerto Rican elected officials in creating a comprehensive National Puerto Rican Agenda that encompasses the problems affecting Puerto Ricans both on the island and in the United States; and

WHEREAS, on December 2, 2015, hundreds of Puerto Rican Community Leaders from across the country traveled to Washington, D.C. in a national call to action, hosting a press conference and a full lobbying day with members of Congress to promote the National Puerto Rican Agenda and call for Congressional action to pass reforms regarding bankruptcy and debt restructuring protections, health care equity, and tax policy before the holiday recess; and

WHEREAS, on January 7, 2016, a Pennsylvania Statewide PA 4 PR Meeting was held in the City of Lancaster to unify national Latino and civil rights organizations, labor, women, LGBT, African American and faith-based entities to respectfully ask President Obama and the United States Congress to address the American Fiscal and Humanitarian Crisis in Puerto Rico and the inequalities against 3.5 million U.S. citizens; and

WHEREAS, the crisis in Puerto Rico is emotional, moral, economic, political and social to many of us and understanding of the history and our present moral obligation to declare an absolute repudiation of the congressional neglect to the crisis is a reflection of humanity and solidarity.

WHEREAS, we need to act now to extend equal treatment to Puerto Rico and its American citizens, 3.5 million who reside on the island and 5 million in the diaspora in the United States and abroad.

NOW, THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF WILMINGTON that Council joins the legislative action by city councils in Philadelphia, Chicago, New York City, Cleveland, Orlando, and New Jersey standing in unity on the national call to have the United States Congress and President Obama provide Puerto Rico with the tools to create a pathway to economic recovery.

On the question:

Ms. Cabrera: Yes Mr. President, basically here across the mainland there has been some states that have come together to support Puerto Rico and here in Delaware under the leadership of Edwin Segarra who's here in the audience today, "Delaware for Puerto Rico" has been formed. I have been asked to be part of that movement. We also would be asking members of the General Assembly to adopt a similar resolution. I thankful that State Representative Stephanie Bolden is here as I would be asking her personally as well as others; we want to ask our Governor Markell to join and our Federal Delegation to join the "Delaware for Puerto Rico". And, we'll also be including some community leadership such as the Delaware Hispanic Commission. This is a humanitarian – humanitarian cause. It needs to be done. The Island used to be able to do this and there was changes made in 1985 where they cannot declare bankruptcy anymore. As many might or may not know, Puerto Rico is a commonwealth of the United States and there 3.5 million people who reside on the Island who are U.S. citizens and 5 million in the diaspora of the United States and abroad. So, this crisis in Puerto Rico is emotional, moral, economic, political and social to many us and understanding the history and our present moral obligation to declare an absolute

repudiation of the congressional neglect to the crisis is a reflection of humanity and solidarity.

President Gregory: Ms. Dorsey Walker.

Ms. Dorsey Walker: Mr. President, I'd like to be added as co-sponsor...

President Gregory: So noted.

Ms. Dorsey Walker: ...if it's okay with the sponsor.

Ms. Cabrera: Yes.

President Gregory: So noted. The Clerk will call...Mr. Williams.

Mr. Williams: Co-sponsor also.

President Gregory: So noted.

Ms. Shabazz: Co-sponsor.

President Gregory: So noted.

Mrs. Seijo (City Clerk): Who else? Wait a minute.

President Gregory: Mr. Brown.

Mr. Michael Brown: Sponsor.

Mrs. Seijo (City Clerk): Dorsey Walker, Williams and Michael Brown.

Ms. Shabazz: Shabazz.

President Gregory: And Hanifa Shabazz.

Mrs. Seijo (City Clerk): And Shabazz; thank you.

President Gregory: Okay. The Clerk will call the roll.

Upon a motion of Ms. Cabrera, seconded by Ms. Walsh/Mr. Freel, the aforementioned Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Freel, Michael Brown, Cabrera, Walsh and Wright, and Council President Gregory. Total, thirteen. Nays, none.

President Gregory: Declare it adopted. Ms. Walsh.

Ms. Walsh: No legislation this evening; thanks.

President Gregory: Mr. Wright.

Mr. Wright: Nothing tonight. Thank you.

President Gregory: Mr. Chukwuocha...no, before we do that, let's do this before we forget. Why don't we have a moment of silence for our city employee who passed recently, longtime city employee, Tunde Durosomo. If we could please...thank you.

PETITIONS AND COMMUNICATIONS

Council Members announced committee meetings/civic association meetings and community events/activities throughout their districts. Council Members expressed sympathies of the passing of Tunde Durosomo. Council Members spoke of the following matters: issues regarding the Repair Shop at 40th & Washington and County Councilman Penrose Hollins as well as Commissioner Rhodes were thanked for their assistance in meeting with the business owner; Brandywine School District's referendum, which will go up for a vote on March 27th; complaints received about the conditions of some of the senior high-rises within the City and the need to address those complaints and to be discussed at the next Health, Aging & Disabilities Committee meeting; residents were reminded of several different workshops going on in the upcoming weeks (i.e. Money Matters, Career Development, Job Fair, etc.); limited complimentary tickets of the screening at Penn Cinema (Riverfront) of the movie RACE; residents were encouraged to attend civic associations meetings and the importance of their participation; State Representative Stephanie T. Bolden was thanked and congratulated for her great and courageous work in bringing forth the apology legislation (the States involvement in slavery) that's going to be signed by the Governor on February 10th; HIV Aids "Do the Right Thing" upcoming event in which Executive Director, Darion Gray will be receiving an award for his great work with the Wilmington Youth Leadership Commission was congratulated; the AKA was also congratulate for their recognition of their Founder's Day; Stubbs School Resource Fair; announcement of Commissioner Ramsey's attendance at the February 8th Joint Public Safety Committee and Committee of the Whole meeting; Facebook comments regarding the snow storm and the lack of communication by the Administration; it was noted that the three former mayors (Frawley, Sills and Baker), had a culture of regular leadership meetings and a culture of briefing which alleviated the problem of communication and despite the fact that the Council and the Mayor may have been at odds with one another, there was enough civility and understanding that folk talked to one another in those two forms or one on one; it was duly noted that Public Works Commissioner did attend the Public Works & Transportation Committee to give an update in preparation of the snow storm; residents were commended for working together during the snow storm; the need to start ticketing

people for throwing snow into the street and the need to have a point person to address concerns and/or questions; the men and women of the Department of Public Works were commended for doing an outstanding job as it was a very large and difficult storm; it was also noted that it wasn't just residents throwing snow into the street after being plowed by the City but that companies and business owners were doing it as well; Councilman Michael Brown thanked everyone for their calls, prayers and assistance during the time he was out sick; Council Members were thanked for their support for the "Delaware for Puerto Rico" and Edwin Segarra who travelled here from Pennsylvania was also thanked for bringing this to Council's attention and residents were asked to get involved and to write our Congressional Delegation to make sure that this goes through; new scheme of folks who are undocumented in our nation; Black History month listing of events on WITN 22; for the senior housing complaint, it was suggested that Jane Vincent (Regional Head of HUD) be invited to the committee meeting and also contact the three (3) Congressional Delegation Office so that their staff members can be invited as well; city workers were thanked for the excellent job they do and did during the snow storm (i.e. police officers, sanitation workers); Commissioner Starkey was thanked for attending a civic association to discuss some of the concerns relating to the snow; Gary Fullman was thanked as well for being responsive on a number of different issues concerning the city; and including but not limited to police deployment/policing and the fact that good experienced police officers who are being passed over for jobs and are therefore leaving the city.
