NON-LEGISLATIVE BUSINESS

No non-legislative resolution presented this evening.

LEGISLATIVE BUSINESS

President Gregory: We're dispensing on the regular order of business on calling each Council Member for legislative business since we have one item for this evening. Mr. Williams.

Mr. Williams: Mr. President, I make a motion to call for reconsideration on the question on Substitute No. 1 to Ordinance 16-018 as amended, which failed to be approved at the May 19th meeting. I voted against it.

Mr. Wright: Second.

President Gregory: It's been properly moved and seconded that there be a reconsideration of the Ordinance, all those in favor, so note by "I", Oppose, Abstention. "I's" have it. Mr. Williams.

Mr. Williams: Mr. President, I make a motion for -I make a motion to amend the delete of one position, which was resulted as follows:

On the bottom of Page 7 of Substitute No. 1 to Ordinance No. 16-018, under <u>Section 5</u> in the first sentence, strike out the dollar amount \$73,308,232 and replace it with the lessor dollar amount \$73,235,279. On the bottom of Page 8 of Substitute No. 1 to Ordinance No. 16-018, under the appropriation heading titled <u>To the Department of Public Works</u>, make the following changes:

- o In the top titled **Personal Services**, strike out the dollar amount of \$8,635,339 listed under both the <u>City</u> and <u>Total</u> column headings and replace it in both places with the lessor dollar amount of \$8,562,386.
- In the bottom row titled **Total**, strike out the dollar amount of \$68,385,106 listed under both the <u>City</u> and <u>Total</u> column headings and replace it in both places with the lessor dollar amount of \$68,312,153.

On Page 18 of **Attachment "A"** to Substitute No. 1 to Ordinance No. 16-018 known as the **Department Position Allocation List**, make the following changes in the Department of Public Works in the Water/Sewer Fund:

Strike out the figure 7.00 under both the <u>No.</u> and <u>City</u> headings for the row titled **Plant Mechanic II** and replace it in both places with the lessor figure number 6.00.

Strike out the figure 101.85 under both the <u>No.</u> and <u>City</u> headings for the row titled **Department Total** and replace it in both places with the lessor figure of 100.85.

Turn to Page 20 of **Attachment "A"** to Substitute No. 1 to Ordinance No. 16-018 known as the **Departmental Position Allocation List**, we're going to make the following changes:

- O Under the <u>Water/Sewer Fund</u> heading, strike out the figure 101.85 in the row titled **Public Works** and replace it with the lessor figure of 100.85.
- o Under the <u>Water/Sewer Fund</u> heading, strike out the figure 126.40 in the row titled **Total** and replace it with the lessor figure of 125.40.
- O Under the <u>All Funds</u> heading, strike out the figure 222.00 in the row title **Public Works** and replace it with the lessor figure of 221.00.
- o Under the <u>All Funds</u> heading, strike out the figure 1,108.00 in the row titled **Grand Total** and replace it with the lessor figure of 1,107.00.
- On the bottom row of the page titled **Grand Total**, strike out the figure 1,108.00 and replace it with the lessor figure of 1,107.00.

Mr. Wright: Second.

Ms. Walsh: Mr. President.

President Gregory: That's the motion. I need a second and then we go to the question.

Mr. Wright: I seconded it. I said second.

President Gregory: It's been properly moved and seconded that the Ordinance be amended as noted. All those in favor so note by saying "I"...

Ms. Walsh: I have a question.

President Gregory: ...Opposed, Abstention.

Ms. Walsh: "No".

President Gregory: You can go ahead Ms. Walsh. "I's" have it.

Ms. Walsh: My question Mr. President, I know what you're trying to do here this evening and I'm not going to get into all my reasons for not agreeing with that but how we be amending something that's still a defeated bill right?

President Gregory: You want to go ahead? I'm not doing this.

Mr. Wright: Sanjay.

Mrs. Seijo (City Clerk): The mic.

Ms. Cabrera: Your microphone.

Mr. Wright: At the bottom.

Mr. Sanjay Bhatnagar (Assistant City Solicitor): The authority is on – on, from Rule 21 of the City Council's Rule. A question can be reconsidered at the present meeting or the next meeting. This is the next meeting. It was properly brought forth by Mr. Williams who voted against it which was the prevailing party from the last meeting. Once the – once the motion to reconsideration was approved, the question is before the assembly, that question is debatable and therefore amendable. It that's consistent with the City Council Rules and Robert's Rules.

President Gregory: The Clerk will call the roll for the Ordinance; yes and no.

Ms. Walsh: The amendment didn't pass yet.

President Gregory: For the amendment. No, we already did the amendment. The amendment was done. That's done. Now you're voting for the Ordinance and you're voting against it.

Mr. Michael A. Brown: That's right.

President Gregory: As amended. The amendment was done. Let's go.

Upon a motion of Mr. Williams, seconded by Mr. Wright, the aforementioned Substitute No. 1 to Ordinance No. 16-018, As Amended, was reconsidered and adopted by the following Yea and Nay Roll Call Vote: Yeas, Council Members Darius Brown, Shabazz, Prado, Dorsey Walker, Williams, Michael Brown and Wright, and President Gregory. Total, eight. Nays, Chukwuocha, Congo, Freel, Cabrera and Walsh. Total, five.

President Gregory: Declare it adopted. We entertain a motion to adjourn.
