

**AN ORDINANCE TO FURTHER EXTEND CERTAIN TRAFFIC/PARKING REGULATIONS.**

**WHEREAS**, pursuant to the Charter of the City of Wilmington (the “City”) and Chapter 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to extend the traffic/parking regulations set forth herein; and

**WHEREAS**, pursuant to Substitute No. 1 to Ordinance No. 14-024 (the “Substitute Ordinance”), as amended, the Council temporarily authorized certain traffic and parking regulations affecting East 12<sup>th</sup> Street, East 13<sup>th</sup> Street, North French Street and Wilson Street until May 14, 2015; and

**WHEREAS**, pursuant to Ordinance No. 15-016, the Council extended the time period of the traffic and parking regulations set forth in the Substitute Ordinance until May 14, 2016, except for the provisions set forth in Section 7 of the Substitute Ordinance, which were rescinded; and

**WHEREAS**, the Council deems it appropriate to further extend the traffic and parking regulations in effect pursuant to Ordinance No. 15-016 for a temporary period of one (1) year.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON HEREBY ORDAINS:**

**SECTION 1.** That the street direction for Wilson Street, between East 12<sup>th</sup> Street and East 13<sup>th</sup> Street, continue from One-way northbound to One-way southbound, as shown conceptually in the attached drawing labeled “Traffic Control Plan Community Education Building Corp.”

**SECTION 2.** That a “**STOP**” sign control remain installed on Wilson Street southbound at the intersection of East 12<sup>th</sup> Street.

**SECTION 3.** That a “**NO PARKING CHILD CARE DROP OFF 6:00 A.M. TO 6:00 P.M., Except Saturdays and Sundays**” signs remain installed at the following locations:

- a. Northbound side of East 12<sup>th</sup> Street between North Walnut Street and North French Street.
- b. Eastbound side of North French Street beginning at the northerly building line of East 12<sup>th</sup> Street and extending north 168 feet.


**SECTION 4.** That a “**NO PARKING LOADING ZONE 8:00 A.M. TO 6:00 P.M., Except Saturdays and Sundays**” sign remain installed on eastside of North French Street beginning 75 feet north of the northerly building line of East 12<sup>th</sup> Street and extend north 40 feet.

**SECTION 5.** That a “**NO PARKING POLICE PARKING ONLY**” sign remain installed on the northside of East 12<sup>th</sup> Street beginning as the easterly building line of North French Street and extending east 20 feet.

**SECTION 6.** This Ordinance shall become effective immediately upon its date of passage by the City Council and approval by the Mayor for a temporary period of one (1) year, at which time the traffic regulations shall be reviewed by City Council.
