LEGISLATIVE BUSINESS

President Pro Tempore Walsh: Mr. Chukwuocha.

Mr. Chukwuocha: Nothing tonight Madame President. Thank you.

President Pro Tempore Walsh: Mr. Darius Brown.

Mr. Darius Brown: Yes Madame President, I have a Resolution to present.

Mr. Darius Brown presented Resolution No. 16-064 (Agenda #4253) as follows:

WHEREAS, approximately 2.2 million Americans are behind bars – a figure that accounts for roughly a quarter of the world’s inmate population; and

WHEREAS, each year, more than 600,00 inmates are released from federal and state prisons and 11.4 million more cycle through local jails; and

WHEREAS, in Wilmington, some 1,200 individuals have historically been released from carceral institutions each year; and

WHEREAS, the some 70 million Americans who have a criminal record are often disqualified from various employment opportunities, thereby preventing them from returning to society as full participants – despite having paid their debt to society; and

WHEREAS, the White House has launched the Fair Chance Business Pledge, an effort to encourage private entities throughout the country to eliminate barriers to employment and opportunity to those with a criminal record; and

WHEREAS, following the encouragement of City Council, the Delaware State Chamber of Commerce has expressed its willingness to promote this initiative among its members, including those in the City of Wilmington and beyond.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that the Council supports the efforts of the White House in establishing and promoting the Fair Chance Business Pledge, and respectfully encourages businesses that are located in, and serve, the City of Wilmington to consider joining in this important national initiative.

On the question:

Mr. Darius Brown: Yes Madame President, this Resolution shares in the spirit and wishes of this Council and this body to support the Fair Chance Business Pledge. We have engaged the State Chamber of Commerce which has committed to support the Fair Chance Business Pledge with their membership and providing employment opportunities for individuals that were previously incarcerated. As we all know that there's on average of about 1,200 individuals mainly from 19801, 19802 and increaselly from 19805 in our City that return to us each year from incarceration. So, that's the wishes of this Resolution and Council with thus support of the Delaware State Chamber of Commerce supporting this pledge.

President Pro Tempore Walsh: Thank you Mr. Brown. Anyone? Council Member Dorsey Walker.

Ms. Dorsey Walker: Thank you Madame President. I would just like to be added as a cosponsor.

Ms. Shabazz: Thank you Madame President. I too is one who has been supportive - an advocate of workforce development and local hire, I think this is a very good Resolution and would love to have my name on to it.

On the question:

Mr. Freel: Yes, we're making some changes here in the Human Resources Department. We're reclassifying two of the Human Resources Administrators from a "Q" to a "MO4" and then we're changing the title of the "Employee Relations Advisor" to a "Human Resources Administrator". The net increase in cost for these changes is \$8,311. The reason for trying to do this is in the past these three employees kind of worked in siloes, so if one was out, that work load – the work assignment kind of stopped. This way they're going to take the opportunity to cross train these three individuals so they don't lose anything when somebody – somebody is out and all this is taking place in the Employee Services Division.

On the question:

Mr. Freel: Yes Madame President, we've done these bonds anticipation notes before. I think most Councilmembers agree we still need a lot of work to be done on our streets' condition of the pavement but we have expended all the dollars that we have presently and what this would do, it provides us with six million dollars and then the next time we go to the market we will repay this note. My understanding is we're getting a very good interest rate right about one percent and we only pay interest on those funds that we've actually used and expended.

President Pro Tempore Walsh: Anyone else? Council Member Darius Brown.

Mr. Darius Brown: Thank you Madame President. I do want to stress how important this is when we talk about infrastructure investment in the City particularly around this past General Assembly session. We did not receive any funds in the bond bill for infrastructure investment and this is a ban, it's not a band aid but in many – in many cases it is when it looks at the demand and the amount of infrastructure, street resurfacing, paving and water/sewer and so many of the other infrastructure investment needs we have here in the City of Wilmington. So, we're doing this to be responsible but I look forward to us hopefully doing more in the FY'18 Capital Budget.

On the question:

Mr. Freel: Yes Madame President, all we're doing here really is refinancing a 2013 bond issuance we did. It was a three year term; it was to provide funds for the Wilmington Housing Partnership to do acquisitions, construction rehabilitation, they had not expended those funds, so, we're going to go ahead and repay that issuance and do this new issuance for up to – could not exceed four million dollars and once again, we're getting a very good interest rate on this. It would be just shy of one in a half percent and once again, this issuance will be for three years and they have enough inventory right now of projects they're working on to be able to pay this off from their sale proceeds.

President Pro Tempore Walsh: Anyone else? The Clerk will call the roll.

Upon a motion of Mr. Freel, seconded by Mr. Williams, the aforementioned Ordinance was read for the third and final time and was adopted by title and section recurring to the Enacting Clause and was passed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Darius Brown, Shabazz, Dorsey Walker, Williams, Freel, Michael Brown and Wright, and President Pro Tempore Walsh. Total, nine. Nays, none. Absent, Council Members Congo, Prado and Cabrera, and Council President Gregory. Total, four.

President Pro Tempore Walsh: Declare it adopted.

Mr. Freel: That's all I have. Thank you.

President Pro Tempore Walsh: Thank you Mr. Freel. Mr. Michael Brown.

Mr. Michael Brown: Madame President, thank you for asking me but I really don't have anything tonight. Thank you.

President Pro Tempore Walsh: You're welcome. Mr. Wright.

Mr. Wright: No legislation.

President Pro Tempore Walsh: Okay, thank you.

Mr. Williams: Motion to adjourn.

Mr. Michael Brown/Mr. Wright/Mr. Freel: Second.
