

**AN ORDINANCE TO ENACT CERTAIN TRAFFIC/PARKING REGULATIONS**

WHEREAS, the City Council has enacted the provisions of Section 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to enact the traffic/parking regulations set forth herein.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF WILMINGTON HEREBY ORDAINS:**

**SECTION 1.** That “STOP” signs be installed at the following locations:

- a. On Lobdell Street (Eastbound) intersecting Christina Avenue
- b. On Porter Street (Southbound) intersecting Maple Street
- c. On Porter Street (Southbound) intersecting Linden Street

**SECTION 2.** That “NO STOPPING STANDING OR PARKING BETWEEN THE HOURS 6:00 P.M. TO 6:00A.M. Between Signs” signs should be installed on the westside of North King Street beginning at the southerly building line of West 5<sup>th</sup> Street and extending south 60 feet.

**SECTION 3.** That “NO PARKING AT ANYTIME” signs be placed on Menser Way within the Millstone Subdivision.

**SECTION 4.** That “NO PARKING URBAN SCHOOL STAFF PARKING ONLY 7:00 A.M. TO 5:00 P.M., Except Saturdays and Sundays” signs be installed at the following locations:

- a. On the northside of West 7<sup>th</sup> Street beginning 264 feet east of the easterly building line of North Walnut Street and extending east 138 feet.
- b. On the northside of East 11<sup>th</sup> Street beginning at the westerly building line Thatcher Street and extending west 107 feet.

**SECTION 5.** That “THIRTY-MINUTE PARKING 6:00 A.M. TO 10:00 P.M., “Between Signs” signs be installed on the westside of Justison Street beginning 30 feet north of the northerly building line of Harlan Boulevard and extending north 120 feet.

**SECTION 6.** That “FIFTEEN-MINUTE PARKING BETWEEN THE HOURS of 8:00 A.M. and 6:00 P.M., DAILY EXCEPT SUNDAYS” signs be installed on the southside of Delaware Avenue beginning 30 feet from the easterly building line of North DuPont Street and extending 30 feet east.

**SECTION 7.** That “**FIFTEEN-MINUTE PARKING BETWEEN THE HOURS OF 8:00 A.M. and 6:00 P.M., DAILY EXCEPT SUNDAYS, BETWEEN SIGNS**” signs be installed on the southside of West 8<sup>th</sup> Street beginning 30 feet from the easterly building line of North Union Street and extending 60 feet east.

**SECTION 8.** That “**FIFTEEN-MINUTE PARKING BETWEEN THE HOURS OF 10:00 A.M. and 4:00 P.M., DAILY EXCEPT SUNDAYS, BETWEEN SIGNS**” signs be installed on the eastside of North Lincoln Street beginning 154 feet from the southerly building line of West 11<sup>th</sup> Street and extending 50 feet south.


**SECTION 9.** That the portions of legislation that designates the following be hereby **RESCINDED**:


- a. Removal of “FIFTEEN MINUTE PARKING 8:00 AM TO 6:00 PM, Except Sunday” signs on the eastside of North Lincoln Street beginning 40 north of the northerly building line of West 6<sup>th</sup> Street and extending north 40 feet.

**SECTION 10.** This ordinance shall become effective immediately upon its date of passage by the City Council and approval by the Mayor.




