WHEREAS, on December 3, 2015, the Council passed Resolution No. 15-071, which approved a collective bargaining agreement ("CBA") between the CITY OF WILMINGTON, a municipal corporation of the State of Delaware, and the DELAWARE PUBLIC EMPLOYEES, COUNCIL 81 AFSCME AFL-CIO AND ITS AFFILIATE LOCAL UNION 1102B ("Local 1102B"), with a term of July 1, 2015 through June 30, 2018; and

Council Member Freel SYNOPSIS AND FISCAL IMPACT: This Resolution approves an amendment to the collective bargaining agreement ("CBA") between the City of Wilmington and the Delaware Public Employees, Council 81 AFSCME AFL-CIO and its Affiliate Local Union 1102B ("Local 1102B"). The CBA was approved by Council on December 3, 2015 with a term of July 1, 2015 through June 30, 2018. The amendment authorizes certain compensation increases and one-time payments to Local 1102B employees. The total costs in FY2017 and F2018 resulting from the compensation increases and one-time payments are estimated to be \$18,389 and \$18,449, respectively. The fiscal impact in relation to the total FY2017 Police Department Personal Services budget is de minimis and will either be offset by normal operational savings elsewhere in the Police Department's budget accounts or will be covered through internal departmental budget transfer(s) as approved by the Office of Management and Budget.

## AMENDMENT OF COLLECTIVE BARGAINING AGREEMENT

This Amendment of Collective Bargaining Agreement ("Amendment") is between the City of Wilmington ("City") and the American Federation of State, County and Municipal Employees, Local 1102B ("Union") (collectively, the "Parties").

WHEREAS, the Parties are parties to a collective bargaining agreement with a term July 1, 2015 through June 30, 2018 ("CBA"); and

WHEREAS, the CBA contains provisions which permit the Parties to reopen the CBA for the purpose of negotiating wages for Fiscal Years 2017 and 2018 ("Reopener"); and

WHEREAS, the Parties invoked the Reopener and negotiated wages for Fiscal Years 2017 and 2018.

NOW, THEREFORE, the Parties agree as follows:

- 1. Revise Section 27.2 to read as follows:
  - 27.2 Current employees who were employed by the City on the date this Agreement is ratified by the membership and approved by the Mayor and Council, shall receive a one-time payment in the amount of \$250.00. Current employees who are employed by the City on July 1, 2017, shall receive a one-time payment of \$250.00.
- 2. Revise Exhibit F Wages and Salaries, as attached.
- 3. The terms of this Amendment shall be incorporated by reference into the CBA and shall be binding and effective as if fully set forth in the CBA.
- 4. The terms of this Amendment shall control over any contrary terms in the CBA.
