

SUBSTITUTE NO. 1 TO ORDINANCE NO. 17-027

AN ORDINANCE TO ENACT CERTAIN TRAFFIC/PARKING REGULATIONS

WHEREAS, pursuant to the City Charter and Chapter 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to enact the traffic and parking regulations set forth herein.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF WILMINGTON
HEREBY ORDAINS:**

SECTION 1. That “**ALL-WAY STOP**” signs be installed at the following locations:

- a. West 7th Street and North Madison Street
- b. West 12th Street and North Madison Street
- c. West 6th Street and North Jefferson Street
- d. West 3rd Street and North Jefferson Street
- e. West 5th Street and North Jefferson Street
- f. West 6th Street and North Jefferson Street
- g. West 9th Street and North Jefferson Street
- h. West 10th Street and North Jefferson Street
- i. West 5th Street and North West Street
- j. West 6th Street and North West Street
- k. West 9th Street and North West Street
- l. West 5th Street and North Monroe Street

SECTION 2. That “**NO PARKING ANY TIME**” signs be installed at the following locations:

- a. Both sides of the 800 block of Taylor Street.

b. Northside of "A" Street beginning 152 feet from the easterly building line of North Walnut Street and extending east 30 feet.

SECTION 3. That "**NO PARKING LOADING ZONE**" signs be installed on the westside of North King Street, beginning at the northerly building line of East 9th Street and extending north 100 feet.

SECTION 4. That "**NO PARKING CHILD DROP OFF/PICK UP, 7:00 AM TO 10:00 AM, EXCEPT SATURDAYS AND SUNDAYS**" signs be installed on the southside of West 4th Street, beginning 77 feet west of the westerly building line of Greenhill Avenue, and extending west 58 feet.

SECTION 5. That "**NO PARKING CHILD DROP OFF/PICK UP, 3:00 PM TO 5:00 PM, EXCEPT SATURDAYS AND SUNDAYS**" signs be installed on the southside of West 4th Street, beginning 77 feet west of the westerly building line of Greenhill Avenue, and extending west 58 feet.

SECTION 6. That the portions of legislation that designate the following be hereby **RESCINDED**:

a. **Removal of "2 HOUR PARKING 8AM TO 6PM, EXCEPT SATURDAYS AND SUNDAYS"** signs on both sides of the 800 block of Taylor Street.

b. **Removal of "NO PARKING CHILD DROP OFF/PICK UP, 7:00 AM TO 10:00 AM, EXCEPT SATURDAYS AND SUNDAYS"** signs on the southside of West 4th Street, beginning 77 feet west of the westerly building line of Greenhill Avenue, and extending west 35 feet.

c. **Removal of “NO PARKING CHILD DROP OFF/PICK UP, 3:00 PM TO 5:00 PM, EXCEPT SATURDAYS AND SUNDAYS”** signs on the southside of West 4th Street, beginning 77 feet west of the westerly building line of Greenhill Avenue, and extending west 35 feet.

SECTION 7. That the street direction for Anchorage Street, between Beech Street and Oak Street be changed to **“ONE-WAY-SOUTHBOUND”** only.

SECTION 8. That **“ALL-WAY STOP”** signs be installed at the following locations:

- a. On North Van Buren Street (Southbound) intersecting Lovering Avenue
- b. On North Adams Street intersecting Lovering Avenue

SECTION 9. That **“NO PARKING STREET CLEANING 10:00 A.M. TO 12:00 P.M., TUESDAYS ONLY”** signs be installed at the following locations:

- a. South Franklin Street between Sycamore Street and Beech Street
- b. Sycamore Street between South Harrison Street and South Van Buren Street
- c. South Van Buren Street between Maple Street and Sycamore Street

SECTION 10. That the portions of legislation that designate the following be hereby **RESCINDED:**

- a. **Removal of “NO PARKING STREET CLEANING 10:00 A.M. TO 12:00 P.M., FRIDAYS ONLY”** signs on South Franklin Street between Sycamore Street and Beech Street.

b. **Removal of "NO PARKING STREET CLEANING 10:00 A.M. TO 12:00 P.M., FRIDAYS ONLY"** signs on Sycamore Street between South Harrison Street and South Van Buren Street.

c. **Removal of "NO PARKING STREET CLEANING 10:00 A.M. TO 12:00 P.M., FRIDAYS ONLY"** signs on South Van Buren Street between Maple Street and Sycamore Street.


SECTION 11. This Ordinance shall become effective upon its passage by City Council and approval by the Mayor.


