Council Members Chukwuocha Oliver McCoy Harlee WHEREAS, pursuant to the City Charter and Chapter 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to enact the traffic and parking regulations set forth herein.

## THE COUNCIL OF THE CITY OF WILMINGTON HEREBY

## **ORDAINS:**

**SECTION 1.** That "**ALL-WAY STOP**" signs be installed on North Washington Street at the intersection of West 37<sup>th</sup> Street.

**SECTION 2.** That "**NO PARKING AT ANYTIME**" signs be placed on the eastside of North Claymont Street, between Peach Street and Christina Avenue.

**SECTION 3.** That "**NO PARKING BUS LOADING ZONE**" signs on the eastside of North Claymont Street beginning 20 feet north of the building line of Todd's Lane and extending north 505 feet.

**SECTION 4.** That "**ROAD CLOSED EXCEPT TO SCHOOL BUSES 3:00 P.M. TO 4:00 P.M. DAILY, EXCEPT SATURDAYS AND SUNDAYS**" signs be installed at the intersections of Todd's Lane and North Claymont Streets and East 35<sup>th</sup> Street and North Claymont Streets for the use of the Eastside Charter School.

**SECTION 5.** That the portions of legislation that designates the following be hereby **RESCINDED**:

a. Removal of "NO PARKING CHILD DROP OFF 7:30 A.M.
 TO 8:30 A.M., Except Saturday and Sunday" signs on the eastside of
 North Claymont Street beginning 250 feet north of the building line of

Todd's Lane and extending north 125 feet.

- b. Removal of "NO PARKING CHILD DROP OFF 3:00 P.M.

  TO 5:00 P.M., Except Saturday and Sunday" signs on the eastside of

  North Claymont Street beginning 250 feet north of the building line of

  Todd's Lane and extending north 125 feet.
- c. Removal of "15 MINUTE PARKING 8:00 AM TO 6:00 PM, Except SUNDAY" on the eastside of South Union Street beginning 40 feet south of the building line of Tulip Street and extending south 20 feet.
- d. Removal of "2 HOUR PARKING 8AM TO 6PM, Except
   Saturday and Sunday" on the westside of Thatcher Street between East
   24<sup>th</sup> Street and East 25<sup>th</sup> Street.

SECTION 6. That "2 HOUR PARKING 8:00 AM TO 6:00 PM, Except Saturdays and Sundays" signs be installed on both sides of the 800 block of Taylor Street.

**SECTION 7.** That "1 HOUR PARKING 6:00 AM TO 6:00 PM, Except Saturdays and Sundays" signs be installed on the eastside of Ogle Avenue beginning 20 feet north of the northerly building line of Lancaster Avenue and extending north 76 feet.

**SECTION 8.** This substitute ordinance shall become effective immediately upon its date of passage by the City Council and approval by the Mayor.
