WHEREAS, Resolution 16-060, passed by the previous session of City Council, established the Council Organization Commission, which was charged with reviewing Council's size and structure, as well as the nature of the Council President's commitment and the reasonableness of staggering Council terms; and

WHEREAS, on August 30, 2017, the Council Organization Commission issued its final report with a set of findings and recommendations for Council's consideration; and

**WHEREAS**, Council seeks to formally accept the report (attached herein) of the Council Organization Commission into the record.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that City Council hereby accepts into the record the

report of the Council Organization Commission, which was established by Resolution 16-060.

Note: The above referenced Report is on file in the City Council Office.

Upon a motion of Council Member Chukwuocha, seconded by Council Members Walsh and Freel, the above Resolution was before the Council for its consideration.

Council Member Chukwuocha noted the purpose of the Resolution, which he stated this was accepting into record the Council's Organization Commission Report. WHEREAS, the purpose of this initiative was to engage in strategic and critical thinking exercises designed to help members of this legislative body to reflect on and devise missions and priorities for their term in office, and the institution of City Council more generally; and

WHEREAS, the results of these intensive efforts include a set of mission statements for Council and its standing committees, as well as a comprehensive collection of policy priorities and objectives identified by members; and

WHEREAS, the Strategic Planning Process has been engineered to be flexible, so that it can be updated and modified to accommodate developments, challenges and opportunities that might come in the future; and

WHEREAS, with the first Strategic Planning Process report in hand, Council wishes to accept and adopt this plan (attached herein) as a dynamic resource to help guide policy, advocacy and governance objectives through the rest of the 107<sup>th</sup> Session of City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that City Council hereby accepts and adopts the results of the Wilmington City Council Strategic Planning Process.

President Shabazz: Declare it adopted.

On behalf of President Shabazz, Council Member Chukwuocha presented Resolution No. 17-090 (#4456) as follows:

WHEREAS, in a time of great division in our country, it is crucial for state and local governments to be engaged with federal officials on matters and policies that particularly affect leaders at the local level; and

WHEREAS, cities presently face particular challenges related to funding the provision of local services, and city leaders across the country have raised concerns about how cities will fare in light of tax reform solutions that have been proposed in Washington, D.C.; and

WHEREAS, legislation was recently introduced in the United States Congress that would eliminate the State and Local Tax (SALT) Deduction, which has been in place since the establishment of the federal income tax in 1913; and

WHEREAS, the SALT Deduction provides some of the funding that state and local governments utilize to provide public resources and services, including education, law enforcement, fire protection and roads. Aside from these public resources, the SALT Deduction also makes it easier for people to become homeowners, and removes the possibility for income to be taxed twice; and

WHEREAS, the elimination of the SALT Deduction could cause considerable harm to state and local governments, and by extension, residents of those jurisdictions. According to an intensive report prepared by the Government Finance

Officers Association, approximately 30% of taxpayers would be negatively impacted by the elimination of the SALT Deduction; and

WHEREAS, the National League of Cities and the United States Conference of Mayors, among other organizations, have recently formulated campaigns joining cities advocating against the elimination of the SALT Deduction and encouraging the federal government to stand with cities when considering any form of tax reform.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that the Council strongly encourages the United States Congress to consider the financial challenges and responsibilities facing cities when reviewing proposed tax reform, and to consider the implications of eliminating the SALT Deduction for state and local governments.

Upon a motion of Council Member Chukwuocha, seconded by Council Member Walsh, the above Resolution was before the Council for its consideration.

President Shabazz: Declare it adopted.

Council Member Freel presented <u>Resolution No. 17-081</u> (Rev. 1, #4441) as follows:

WHEREAS, Section 2-369 of the City Code requires grants awarded by the Mayor, City Council or the City Treasurer in the amount of \$5,000 or more to be approved by resolution of City Council; and

WHEREAS, City Council wishes to award a grant to the Culture Restoration Project (Behind Those Bars) in the amount of \$10,000; and

WHEREAS, this grant funding will support the facilitation of Beyond Those Bars, a violence prevention education program which uses hip-hop as a medium to teach youth the skills necessary to reduce or altogether eliminate involvement in risky behavior such as violent crime and delinquency – a valuable and critically important message to convey to our youth; and

WHEREAS, this cause is closely aligned with the priorities of the City Council Strategic Planning Process, specifically in its focus on youth and its connection to the recommendations of the Centers for Disease Control and Prevention report on Wilmington.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that City Council hereby approves the issuance of a grant from City Council to the Culture Restoration Project (Behind Those Bars) in the amount of \$10,000.

Upon a motion of Council Member Freel, seconded by Council Members Walsh and Williams, the Resolution was before the Council for its consideration.

Council Member Freel spoke on the purpose of the Resolution and Council Member Guy made some comments on the Resolution as well.

Council Member Turner asked for clarity of President Shabazz being the lead sponsor on the Resolution.

President Shabazz responded that Councilman Freel is the lead sponsor on the Resolution.

Council Member Turner asked President Shabazz if Councilman Freel wanted to hold it and she didn't want to hold, could it had been up for discussion on the day that Councilman Guy spoke of?

President Shabazz: Council Member Guy.

Council Member Guy: Yes, I have two pieces of legislation. Oh, that's

right...

President Shabazz: Not on the agenda.

Council Member Guy: ...you didn't put them on the agenda, again.

President Shabazz: Council Member Walsh.

Council Member Walsh: Yes Madam President, I have two Resolutions and an Ordinance.

Mrs. Seijo (City Clerk): Thank you.

WHEREAS, the proposed grant funds would be used for advanced training to assist in the implementation of a group violence reduction strategy; and

WHEREAS, no matching funds are required; and

**WHEREAS**, the Council deems it necessary and proper to authorize the grant application, for the aforesaid purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington Police Department's subgrant application to the Delaware Criminal Justice Council in the amount of \$10,000.00 is hereby authorized.

**BE IT FURTHER RESOLVED** that the Chief of Police, or his designee, shall be authorized to take all necessary actions to accept any and all funds associated with the grant application and to fulfill the grant requirements.

Upon a motion of Council Member Walsh, seconded by Council Member Williams, the Resolution was before the Council for its consideration.

WHEREAS, the City, through the Wilmington Police Department, has submitted grant applications to the State of Delaware for funding from the State Aid to Local Law Enforcement and Emergency Illegal Drug Enforcement funds for a total of \$60,742.81; and

WHEREAS, the proposed grant funds would be used to provide advanced training including S.W.A.T. training, Pro-active Internal Affairs Investigation Training, and Supervisory Leadership Training as well as overtime funding for the Wilmington Police Department's Drug, Vice and Organized Crime Division; and

WHEREAS, no matching funds are required; and

**WHEREAS**, the Council deems it necessary and proper to authorize the grant application, for the aforesaid purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington Police Department's grant applications to the State of Delaware in the total amount of \$60,742.81 is hereby authorized.

**BE IT FURTHER RESOLVED** that the Chief of Police, or his designee, shall be authorized to take all necessary actions to accept any and all funds associated with the grant application and to fulfill the grant requirements.

Upon a motion of Council Member Walsh, seconded by Council Member Williams, the Resolution was before the Council for its consideration.

Council Member Walsh spoke on the purpose of the Resolution.

President Shabazz moved for the Clerk to call the roll.

The above Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Chukwuocha, Congo, Oliver, Harlee, Turner, Williams, Freel, Adams, Dixon, Guy and Walsh, and Council President Shabazz. Total, twelve. Nays, none. Absent, Council Member McCoy. Total, one.

President Shabazz: Declare it adopted.

Council Member Walsh: I have an Ordinance for introduction.

Council Member Walsh presented and called for the first and second reading Ordinance No. 17-053 (#4460) entitled:

AN ORDINANCE TO AMEND CHAPTER 36 OF THE CITY CODE TO REPEAL SECTION 36-9 THEREOF REGARDING REGULATIONS OF ITINERANT PERFORMERS

The above Ordinance was given separate readings by title only and upon a motion of Council Member Walsh, seconded by Council Member Williams, the Ordinance was received, recorded and referred to the Public Safety Committee. Motion prevailed.

Council Member Oliver: Madam President...

Council Member Walsh: That's all I have this evening. Thank you.

Council Member Oliver: ...may I be excused?

President Shabazz: Thank you. Petitions and communications...you're

excused.

Council Member Oliver: Thanks.

### **PETITIONS AND COMMUNICATIONS**

Council Members announced civic association/community and committee meetings as well as community events/activities throughout their districts. Council Members also spoke about the following matters: the Governor's hearings and initiative around education for our children; complaints regarding elevators not working in senior high rises; negativity in the News Journal; the need to do a better job in respecting each other and respecting the Council as a whole as well as respecting the constituents in the City of Wilmington; the current 2028 plan; residents were reminded of the final week of leaf removal; vigil tonight at 8pm for the young man that was murdered in Cools Springs recently; constituents were reminded of safety techniques during the holiday season; the dangers of space heaters; collection of toys to be donated; the need to call the police department when witnessing crime as it is happening in the neighborhoods; 21st Amendment to the Constitution to get rid of prohibition to have liquor stores again; ratification of the 13<sup>th</sup> Amendment, which abolished slavery in the United States and overseas; the Mayor's absence with regards to school districts and the need for leadership as far as schools are concern; Affordable Care Act open enrollment ends on December 15<sup>th</sup> and folks were encouraged to sign up for healthcare; a lot of changes happening all at the same time from transportation to health issues, to seniors to young people, to the school districts and, therefore, folks were encouraged to stay connected in understanding of what's happening in our city; communication sent to members of Council and other folks regarding petitions and communications; the need to stick to the subject matter of the legislation; the lack of respect to the Council President in the last eleven months; and including but not limited to Council was thanked for their continued participation, coming to committee meetings and to continue with open dialogue.
