WHEREAS, pursuant to Section 2-363 of the Code of the City of Wilmington ("City"), the City may apply for and receive grant funds to be used for a wide variety of City activities, subject to the approval of City Council; and

WHEREAS, the City has been approved by the Department of Education for the State of Delaware to receive grant funds from the Federal government for the operation and cost of the Child and Adult Care Food Program (the "Food Program"), which is set to run from October 6, 2014 through May 31, 2015, and which may be extended for one similar period upon the agreement of the parties; and

**WHEREAS**, the amount of the grant funds for the FY2015 Food Program is estimated by the Department of Parks and Recreation to be approximately \$477,163.00 based upon the increased number of meals projected to be served in comparison with the FY2014 Food Program (see Exhibit "A"); and

WHEREAS, although the City is not required to provide matching funds for receipt of these grant funds, the City is initially required to pay the Food Program vendor with City funds and is then reimbursed by the Federal government through the State of Delaware for the payments. There will be no net financial impact on the City, provided the City complies with all Federal and State requirements attached to the Food Program; and WHEREAS, the City has prepared the necessary specifications to solicit bids from prospective vendors to submit bids for a contract to provide meals to eligible participants in the Food Program, which contract may be extended for one additional similar period; and

WHEREAS, the Department of Parks and Recreation has recommended that City Council approve the City's use of the grant funds for the Food Program in accordance with the terms of the grant.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the use of the herein described Federal grant funds received from the State of Delaware for the Food Program be accepted and approved, and the Mayor or his designee, and the City Clerk are hereby authorized to execute any and all appropriate grant documents or other undertakings pursuant thereto as may be necessary. This grant and the resulting contract to provide meals for the Food Program may be extended for one additional similar period upon the agreement of the parties.

AN ORDINANCE TO ADOPT THE SUBDIVISION PLAN KNOWN AS "WALNUT RIDGE AT 15<sup>TH</sup> AND WALNUT STREETS" AND TO ACCEPT THE DEDICATION OF A NEW CITY STREET TO BE NAMED "KOINONIA DRIVE"

Ms. Shabazz: Mr. President, I have a Resolution to present.

Ms. Shabazz presented <u>Resolution No. 14-048</u> (Agenda #3986) as follows:

WHEREAS, under the Downtown Development Districts Act, 22 *Del. C.* §§ 1901, *et seq.* (the "Act"), the State of Delaware may designate districts within Delaware's cities, towns, and unincorporated areas that will qualify for significant development incentives and other State benefits; and

**WHEREAS**, these districts are known as Downtown Development Districts ("Districts"); and

**WHEREAS**, the State is accepting applications for the designation of the initial round of Districts, with such applications being due on November 1, 2014; and

WHEREAS, under the Act, each applicant must submit a plan that includes the boundaries of, and a detailed planning and development strategy for, the proposed District (the "District Plan"); and

WHEREAS, under the Act, each applicant must also propose incentives that address local economic and community conditions, and that will help achieve the purposes set forth in the Act (the "Local Incentives"); and

**WHEREAS**, the City of Wilmington (the "City") plans to submit an application to the State for designation as a District; and

**WHEREAS**, if the City is successful and receives District designation, the District Plan and Local Incentives proposed by the City shall be binding upon the City; and

WHEREAS, the incentives associated with designation as a Downtown Development District would greatly benefit current and future residents, businesses, nonprofit organizations, and others within the City of Wilmington; and

WHEREAS, the incentives associated with designation as a Downtown Development District would assist in stimulating private investment in the City's commercial business districts and their surrounding neighborhoods, improve the commercial vitality of the City's downtown areas and increase the number of residents in the City's downtown areas and surrounding neighborhoods; and

**WHEREAS**, Council of the City of Wilmington strongly believes that it is in the best interest of the City to apply for District designation and supports and recommends that the City submit an application to have certain areas of the City designated as Downtown Development Districts.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that Council supports the City's application to the State of Delaware to have certain areas of the City designated as Downtown Development Districts and Council supports the Application for Designation as a Downtown Development District prepared by the Department of Planning and Development and dated October 16, 2014 (the "Application").

**BE IT FURTHER RESOLVED** that Council authorizes the City to appoint a District administrator (the "Administrator") to file the Application on behalf of the City, and to provide such other documents and information as may be necessary or desirable in connection with the Application.

**BE IT FURTHER RESOLVED** that if the City is successful and the City receives notice that it has been selected for designation as a District: (a) the City shall adhere to the District Plan and the Local Incentives contained in the Application for the duration of the District designation, (b) the Administrator, or his or her designee(s), is authorized to execute such documents and enter into such agreements as may be necessary or desirable in connection with the Downtown Development Districts program and the rights and obligations of the City thereunder and (c) the Administrator, or his or her designee(s), is authorized to carry out all District administrative and reporting requirements on behalf of the City for the duration of the District designation.

Ms. Shabazz: Mr. President, this Resolution is being presented by the Administration and City Council's approval. Once approved, Council will be authorizing the Administration to submit an application to the State by November 1<sup>st</sup> requesting that Wilmington be designated as an official development district under the state's Downtown Development District Act. This new law was enacted during the last session of the

Delaware General Assembly. If Wilmington is designated in development plan assembled by the Administration, Council Committee representatives will be entitled to certain government - - state government funding support in order to achieve the development goals listed in the Plan. Mr. President, the Plan was presented at the Economic Development Committee and there was and it was presented intense - extensively and questions were ask. It comes with great incentives; this designation will transform downtown Wilmington and connected with its adjacent neighborhoods from the east and west of it. The beautiful part about it that the east and west neighborhoods all have revitalization plans that once designated will give them access to resources to bring those plans to life. I think this is a great opportunity for downtown Wilmington and not just downtown Wilmington but the neighborhoods to the west of it and to the east of it being Eastside and West Center City.

President Gregory: Mr. Darius Brown.

Mr. Darius Brown: Thank you Mr. President. As part of this DDD designation, I just want to stress the importance, even though in the name it talks about downtown, how important this is to our neighborhoods and particular for me via eastside neighborhood and the work that's being done there around revitalization and redevelopment, this not only will help with business growth in development but it also helps with housing and I think that's a very strong and important component of this designation. And, when we look at particular areas on Wilmington's east side and west of Market Street that we look at a lot of the dilapidated housing/vacant housing and blight that we see there that with the proper project, we can really turn neighborhoods around (inaudible).

President Gregory: I must thank the Administration particularly through Lenny Sophrin for all the work they did on this and the briefings and updates that they gave City Council. It's truly a partnership between the legislative and the executive branch and we played our little small part, offered observations and suggestions but it was to be driven by the executive branch of government. It was driven by executive branch of government and we will be going – sending that application to Dover as a unified effort. So, I just want thank the Administration through Lenny Sophrin for including us in the process. The Clerk will call the roll.

Ms. Dorsey Walker: Mr. President, after seeing a lot of my constituents kind of going through trials and tribulations, I was thinking about and work with the Finance Department on this Ordinance, in particular Director Sheila Winfrey-Brown as well as other folks – other members from the Administration – in particular the Law Department. And, what we saw, in particular, there are two in my districts that were actually taking care of sick love ones and they needed some kind of reprieve because having that sick love one in their home, the water bill went up, of course they still had to pay taxes. So, what this does is it gives them, people who are taking care of sick love ones, an opportunity to get just a little a bit of a reprieve on their water and taxes. And, it has to be removed every year and they must present legal documentation stating that they are, that sick love one is still living in that home.

President Gregory: Is this your first ordinance?

Ms. Dorsey Walker: Yes. So, I'm about to go through the coals.

President Gregory: I was just reading it and I....

Ms. Dorsey Walker: I just want to make sure you remember there's no pledging.

President Gregory: I was just trying to see if love one is a legal term of order or not. I'm reading the ordinance and I don't see....

Ms. Dorsey Walker: Formal member, sir.

President Gregory: You meant family member?

Ms. Dorsey Walker: Yes, sir. I stand corrected.

President Gregory: Ok. You get ready to confuse me there.

Ms. Dorsey Walker: I do not want to confuse the President of the Council.

President Gregory: I appreciate that.

Ms. Walsh: Mr. President.

President Gregory: Ms. Walsh.

Ms. Walsh: My questions. I have questions.

President Gregory: Please ask your questions.

Ms. Walsh: Not hazing one either, unfortunately.

President Gregory: Ok.

Ms. Walsh: I've really been drawling all week back and forth on this Ordinance because you know, I also see people struggling; I have a great relationship with many seniors in this City and I understand 100 people in the City right now are the only ones affected by it but there's scams born every minutes too. And, the one thing that we're doing in the City is trying to get properties on tax rolls. That part of the reason we're in the financial situation we are now, is because of all the tax exempt properties and tax reduced properties that we have in the City of Wilmington. So, mind you, may have moved with a brother in-law or sister in-law or grandparent or somebody else in the County well you can get a break in the City, let's go and do it. Fine, that might be three people. It's three more than we need. And, it affects the water and the taxes and I don't see any income on this Ordinance either in that - I don't know I get really drawn between that you know, we've been (inaudible) in my family of having to take care of our relatives and we – it's what we did. It's what our religion taught us to do. It's what, you know, if we couldn't have chicken four nights a week, we didn't have chicken four nights a week and it's just what a family does for somebody that they love. And, at some point, we have to say, where is the line in the sand drawn in our City? That there isn't any where out there that has not necessarily anything to do with this bill at all, this is just like collateral damage. But it has to do with what's going on in our streets right now with some of the services that are being not giving and people are angry out here. And, people that I've never would have even thought would have known about this bill, have made comments to me, like, you know, here you go again. Because whether anybody votes on anything or not, whatever it's the blame on the street that City Councilmember gets blame for it. So that's just the way it is here. So, I'm sorry but unfortunately, I can't be voting for it this evening.

President Gregory: Clerk will call the roll.

WHEREAS, the City Council proposes to schedule a public hearing for review of Ordinance No.14-045, or a Substitute thereto, and the respective amendments to the Neighborhood Comprehensive Development Plan for the Baynard Boulevard Analysis Area to be duly advertised in conformity with <u>Wilm</u>. <u>C</u>. '48-51, by publication in any newspaper of general circulation, at least once, not less than fifteen (15) days prior to the date of the public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that the Wilmington City Council hereby schedules a public hearing on Ordinance No. 14-045, or a Substitute thereto, and the respective amendments to the Neighborhood Comprehensive Development Plan for the Baynard Boulevard Analysis Area to be held on November 20, 2014, at 6:30 p.m., in the City Council Chambers, to consider the proposed rezoning of the property within five (5) areas.
