NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington Fire Department is hereby authorized to accept grant funding from FEMA in the amount of nineteen thousand dollars (\$19,000.00).

Mr. Michael Brown: Yes Mr. President, last and but not least, I do have another Resolution.

Mr. Michael Brown presented <u>Resolution No. 14-046</u> (Agenda #3982) as follows:

WHEREAS, it is a fundamental function and responsibility of government to promote the safety and welfare of the public, and the City of Wilmington remains committed to promoting the highest standard of living for its residents and addressing threats to their safety; and

WHEREAS, Delaware, like many other states, has witnessed a dramatic increase in the abuse of heroin and opioids, and as a result, has experienced an increase of people who overdose on these substances; and

**WHEREAS,** medical professionals promote the use of the life-saving drug Naloxone – frequently referred to as `Narcan – as an emergency medication administered to an individual suffering an overdose, as it has proven to counteract the effects of an opioid substance; and

WHEREAS, the Delaware General Assembly has passed legislation, which has since been signed into law, allowing for the purchase of Narcan by members of the general public as a tool to provide aid to those who might abuse opioid substances; and

WHEREAS, the General Assembly has also passed legislation allowing law enforcement officers who undergo proper training to carry Narcan.

### NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF

THE CITY OF WILMINGTON, that the Council supports the initiative of the Delaware General Assembly in introducing and passing legislation to make Narcan available to Delawareans, and also supports the efforts of the Delaware Health and Social Services' Division of Public Health to launch programming to make Narcan available to the public and to encourage law enforcement officers to carry Narcan while on-duty. It is the hope of the Council that continued efforts to identify and implement such tools and programming will help to combat the increase in heroin and opioid overdoses experienced by Delaware residents, and further promote the health and safety of the public.

Mr. Williams: Yes Mr. President, to be added as a co-sponsor and secondly, I just want to go on record in saying, I'm unique in that experience, I've served as uniformed law enforcement officer for twenty years for the City. Just moved into a role as a registered nurse - - legislation such as this or Resolution such as this is something that the City really needs to have moving forward to trying saving lives in the City of Wilmington. As discussed in the Public Safety meeting, our first responder are usually there long before this life saving medication can arrive on the scene and having it to their avail is going to help sustain many lives I feel in the City of Wilmington. So, I'd like to be added as a co-sponsor.

President Gregory: You are. Mr. Brown.

Mr. Michael Brown: Yes Mr. President, this Resolution is being presented by City Council for Council's review and approval and if approved, Council will be supporting recent decisions by the Delaware General Assembly to allow law enforcement officers to be trained to disperse Narcan; a drug that is administered to individuals who overdose on heroin and to allow members of the public to purchase Narcan to assist those who overdose. This Resolution is offered to promote the health and safety of citizens in the first state.

President Gregory: Clerk will call the roll.

Total, nine. Nays, none. Absent, Council Members Congo, Darius Brown, Prado and Cabrera. Total, four.

President Gregory: Declare it adopted. Ms. Walsh.

Ms. Walsh: No legislation.

President Gregory: Mr. Wright.

Mr. Wright: Mr. President, thank you for the acknowledgement; however, I do not have any legislation for tonight.

President Gregory: We going to go to petitions and communications and we're going to go at the request of at least one Council person from the - - in reverse order.
