WHEREAS, Ordinance No. 18-019 has been introduced to City Council to amend the City's Official Building Zone Map relating to changing the zoning classifications of the two blocks (seven parcels) of land known as 100 and 102 N. Walnut Street, 300 East Second Street, 105 N. Poplar Street, 103 N. Poplar Street, 101 N. Poplar Street, 121 N. Poplar Street, and 100 and 110 N. Poplar Street, Wilmington, Delaware, being Tax Parcel ID Nos. 26-043.40-051, 26-043.40-203, 26-043.40-055, 26-043.40-054, 26-043.40-053, 26-043.40-050, and 26-043.40-141 (collectively, the "Parcels"), from C-2 (Secondary Business Centers) to C-3 (Central Retail) zoning classifications; and

WHEREAS, the City Planning Commission has considered the Planning Department's analysis and testimony along with other evidence and testimony at its duly advertised public meeting held on February 20, 2018; and

WHEREAS, at its meeting on February 20, 2018, the City Planning Commission passed Resolution 02-18, which recommended the following amendments to the East Side Comprehensive Plan in order to reflect the proposed rezoning of the Parcels from C-2 (Secondary Business Centers) to C-3 (Central Retail) zoning classifications: (i) revise Plan Map D-9, as illustrated on the map attached hereto and made a part hereof as Exhibit "A": (ii) revise Plan Map E, as illustrated on the map attached hereto and made a part hereof as Exhibit "B"; and (iii) amend Section 1 of Chapter 3 of the Plan, as set forth on Exhibit "C" attached hereto and made a part hereof; and

City Council Findings Supporting Enactment of Ordinance No. 18-019 to Rezone Two Blocks (Seven Parcels) of Land Located in Downtown Wilmington within the Area Bounded by Front, Walnut, Second, and Lombard Streets from C-2 (Secondary Business Centers) to C-3 (Central Retail) Zoning Classifications

Enclosed please find a copy of the findings (the "Findings") prepared in connection with Council's scheduled public hearing on July 2, 2018 regarding the above-referenced zoning ordinance (the "Ordinance"). The Findings supplement the record of the Planning Commission and its report, as well as the record of the Council's public hearing, and the Law Department advises their inclusion in the record as a means of complying with Delaware Court decisions that involve zoning ordinances of County governments, but the principles of which apply to Wilmington, as well.

In this instance, the Findings support the provisions of the Ordinance. The Findings and the Ordinance reflect the recommendations approved by the City Planning Commission at its regular meeting following its public hearing on February 20, 2018. At that meeting, the Planning Commission approved its Resolution No. 03-18, which recommended the rezoning proposed in the Ordinance. The enclosed Findings support those recommendations.

FINDINGS SUPPORTING ENACTMENT OF ORDINANCE NO. 18-019

City Council makes the following findings (the "Findings") regarding the rezoning of the properties that are the subject of Ordinance No. 18-019 (the "Ordinance").

Rezoning Action:

Rezone Two Blocks (Seven Parcels) of Land Located in Downtown Wilmington within the Area Bounded by Front, Walnut, Second, and Lombard Streets from C-2 (Secondary Business Centers) to C-3 (Central Retail) Zoning Classifications. The seven parcels of land are known as 100 and 102 N. Walnut Street, 300 East Second Street, 105 N. Poplar Street, 103 N. Poplar Street, 101 N. Poplar Street, 121 N. Poplar Street, and 100 and 110 N. Poplar Street, Wilmington, Delaware, being Tax Parcel ID Nos. 26-043.40-051, 26-043.40-203, 26-043.40-055, 26-043.40-054, 26-043.40-053, 26-043.40-050, and 26-043.40-141.

- 1. The proposed rezoning action is consistent with the Neighborhood Comprehensive Development Plan for the East Side Analysis Area as proposed to be amended, which is being adopted by City Council resolution contemporaneously herewith.
- 2. The proposed rezoning action would result in a more appropriate zoning classification for the affected parcels because the proposed zoning classification is intended for downtown locations adjacent to Central Business Districts while the current zoning classification is not.
- 3. The proposed rezoning action will not affect the existing land uses within the affected parcels, which will continue to be matter-of-right uses.
- 4. The proposed rezoning action does not introduce a change in maximum heights permitted in the area.
- 5. The proposed rezoning action is appropriate because it is an expansion to an existing C-3 zone located to the west of the affected parcels.
- 6. The proposed rezoning action will have no negative effect on population density patterns and will not overburden public utilities and facilities.
- 7. The proposed rezoning action will not create or excessively increase traffic congestion or otherwise adversely affect public safety.
- 8. The proposed rezoning action will not seriously reduce light and air to adjacent areas, but will be consistent with and complementary to the zoning classifications of nearby zoning districts and the property uses therein.

- 9. The proposed rezoning action will not adversely affect property values in the adjacent areas, nor will it be a deterrent to the improvement or redevelopment of adjacent properties, but rather should have a positive effect.
- 10. The proposed rezoning action will best serve the public welfare and will not constitute a grant of any special privilege to any individual owner of property.
- 11. The proposed rezoning action will not be out of scale but rather will be consistent with the needs and current and future uses of the subject area and the City of Wilmington.
- 12. The proposed rezoning action will not create any isolated districts, but rather will better relate the subject properties to each area and to future best uses of the properties.
- 13. Changing conditions in the area support the proposed rezoning action.
- 14. The proposed rezoning action is consistent with the adjacent zoning.
- 15. The proposed rezoning action adheres to the standards set forth in the applicable provisions of Chapter 48 of the City Code, Title 22 of the Delaware Code, and applicable Delaware case law.

CONCLUSION

This concludes the set of Council's Findings for the rezoning of the properties that are the subject of the Ordinance, as illustrated on the maps attached to the Ordinance. The Ordinance incorporates the recommendations of the City Planning Commission regarding the proposed rezoning action, which were approved at the Planning Commission meeting on February 20, 2018 and contained in its Resolution 03-18.

FRONT, WALNUT, SECOND, AND LOMBARD STREETS FROM C-2 (SECONDARY BUSINESS CENTERS) TO C-3 (CENTRAL RETAIL) ZONING CLASSIFICATIONS

Upon a motion of Council Member Harlee, seconded by Council Member McCoy, the above Ordinance was before the Council for its consideration. Council Member Harlee spoke on the purpose of the Ordinance.

President Shabazz: Clerk will call the roll.

The Ordinance was read for the third and final time and was adopted by title and section recurring to the Enacting Clause and was passed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Oliver: based on the findings; Harlee: based on the findings; McCoy: based on the findings; Freel: based on the findings; Adams: based on papers submitted and the findings; and Dixon: based on the findings; and Council President Shabazz: based on the findings. Total, seven. Nays, Council Members Congo: based on opposition from the community; Turner: based on the community; Williams: based on the lack of community support; and Guy: based on the lack of community support, the fact that the City of Wilmington interfered with the process by slipping in additional properties that have nothing to do with this bus hub, and also no, because we have a member of Council who's a Delaware employee by the agencies that are involved in this who's been intracule part of this, which to me tints the whole process. Total, four. Absent, Council Members Chukwuocha and Walsh. Total two.

President Shabazz: Declare it adopted. Council Member Turner.

Council Member Turner: No legislation tonight Madam President.

President Shabazz: Council Member McCoy.

Council Member McCoy: I have a presentation to present on behalf of Council Member Dixon. I can wait.

President Shabazz: But she's here now.

Council Member McCoy: Oh she's...(inaudible)...then nothing tonight Madam President.

President Shabazz: Thank you. Thank you for assisting. So, Council Member Dixon...

Mrs. Seijo (City Clerk): Go to Williams first.

President Shabazz: ...I'm going to – when I come back to you. Okay? Council Member Williams.

Council Member Williams: Madam President I have an Ordinance to call – present this evening for first and second reading.

Council Member Williams presented and called for the first and second reading Ordinance No. 18-040 (Agenda #4559) entitled:

AN ORIDNANCE TO AMEND CHAPTER 37 OF THE CITY CODE REGARDING OFF-HIGHWAY VEHICLES

The above Ordinance was given two separate readings by title only and upon a motion of Council Member Williams, seconded by Council Member Dixon, the Ordinance was received, recorded and referred to the Public Safety Committee. Motion prevailed.

President Shabazz: Council Member Freel.

Council Member Freel: I have nothing this evening, thank you.

President Shabazz: Council Member Adams.

Council Member Adams: No legislation this evening ma'am.

President Shabazz: Council Member Dixon.

Council Member Dixon: Um yes Madam President, I have a Resolution to

present.

Council Member Dixon presented Resolution No. 18-051 (Agenda #4560)

as follows:

WHEREAS, pursuant to Section 2-363 of the City Code, the Council deemed it necessary and proper to specify the requirements for review and approval of City-sponsored grant applications and proposals, including authorization for expedited grant applications when necessary prior to Council's approval by resolution; and

WHEREAS, the Department of Real Estate and Housing submitted a grant application to the Highmark Delaware in the amount of \$15,000 to support the Neighborhood Clean Team Initiative; and

WHEREAS, the grant funds will be used to support an initiative that is a workforce development effort that will put over 20 people to work over 12 weeks beautifying neighborhoods across the City of Wilmington; and

WHEREAS, the grant does not require any matching funds; and WHEREAS, the Council deems it necessary and proper to authorize the grant application, for the aforesaid purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF

THE CITY OF WILMINGTON that the Department of Real Estate & Housing's grant application to Highmark Delaware in the amount of \$15,000 to support the Neighborhood Clean Team Initiative is hereby authorized.

BE IT FURTHER RESOLVED that the Director of the Department of Real Estate & Housing or his designee is hereby authorized to take all necessary actions to apply for and accept any and all funds associated with the grant application and to fulfill the grant requirements.

FISCAL IMPACT STATEMENT: There is no negative fiscal impact to the City by accepting this grant. The grant requires no matching funds.

Upon a motion of Council Member Dixon, seconded by Council Members McCoy and Williams, the above Resolution was before the Council for its consideration. Council Member Dixon spoke on the purpose of the Resolution.

President Shabazz: Clerk will call the roll.

The Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Congo, Oliver, Harlee, Turner, McCoy, Williams, Freel, Adams, Dixon and Guy, and Council President Shabazz. Total, eleven. Nays, none. Absent, Council Members Chukwuocha and Walsh. Total, two.

President Shabazz: Declare it adopted. Thank you. You could be excused Councilwoman Dixon.

Council Member Dixon: Thank you.

President Shabazz: Councilman Guy.

Council Member Guy: Yes Madam President, I have an Ordinance to present, agenda item 4561 and call for the first and second reading.

Council Member Guy presented and called for the first and second reading Ordinance No. 18-041 (Agenda #4561) entitled:

AN ORDINANCE TO AMEND CHAPTER 8 OF THE CITY CODE TO REQUIRE THAT DEVELOPERS WHO RECEIVE FINANCIAL ASSISTANCE FROM THE CITY OF WILMINGTON ON RESIDENTIAL CONSTRUCTION PROJECTS REQUIRE THEIR CONSTRUCTION CONTRACTORS TO HIRE WORKERS FROM CLASS A APPRENTICE PROGRAMS

The above Ordinance was given two separate readings by title only and upon a motion of Council Member Guy, seconded by Council Member Williams, the Ordinance was received, recorded and referred to the Community Development & Urban Planning Committee. Motion prevailed.

Council Member Guy: Madam President, I have a Resolution, agenda item 4562 to present.

Council Member Guy presented <u>Resolution No. 18-052</u> (Agenda #4562) as follows:

WHEREAS, pursuant to Wilm. C. § 2-3 the mayor retains authority to sub-name by executive order any city street and designate the appropriate sub-name signage pursuant to subsection 2-298(17); and

WHEREAS, it is fitting that the City take steps to properly recognize and pay tribute to Wilmington residents who make a significant impact on history and culture through their exemplary accomplishments; and

WHEREAS, one such resident is the world-renowned musician Wilbert "Wilby" B. Fletcher. Mr. Fletcher was born and raised in the City of Wilmington, and first rose to prominence for his artistic ability performing with the bands of McCoy Tyner and Grover Washington, Jr.; and

WHEREAS, Mr. Fletcher was first introduced to drums at the young age of four, and participated in the high school band at P.S. Dupont High School. Mr. Fletcher began working as professional drummer at the age of fifteen, often playing at nightclubs with bands performing a variety of music. Upon graduating from P.S. Dupont High School in 1972, Mr. Fletcher went on to attend the Berklee College of Music in Boston, Massachusetts. His father, the late Wilbert Fletcher, is credited with introducing Mr. Fletcher to jazz music, leading him to a robust career in music; and

WHEREAS, Mr. Fletcher first joined the McCoy Tyner Quartet in the seventies, and had his first appearance with the band at the Jazz Showcase in Chicago. His natural ability was put to the test at the Jazz Showcase, as he had not had any time for a rehearsal prior to performing, and yet he still managed to hold his own. He performed with Tyner for ten years, and appeared on the recording *Atlantis*. Mr. Fletcher would then go on to work with violinist John Blake, with whom he had a close relationship. He is featured in John Blake's first two albums, *Maiden Dance* and *A Twinkling of an Eye*; and

WHEREAS, Mr. Fletcher was known for his incredible range of talents and interests, reflected in the number of entertainers he played with all over the world, including Charles Earland, Ahmad Jamal, Dianne Reeves, Sadao Watanbe, Herbie Mann and Roberta Flack. While Mr. Fletcher was a very talented man, he was also a father to six wonderful children; and

WHEREAS, though Mr. Fletcher achieved many accolades and recognition as a musician, he also found time to play for the church services at Shiloh Baptist Church in Wilmington, and would also provide drum theory lessons to interested youth in the community. Mr. Fletcher was more than a performer with incredible talent; he was also a community educator and leader; and

WHEREAS, City Council wishes to recognize the exceptional accomplishments, talent and contributions of Wilbert "Wilby" B. Fletcher. Mr. Fletcher's musical ability inspired many, not only in Wilmington but throughout the world. Mr. Fletcher also brought that talent into his community, playing at a local church and providing lessons to children. Council therefore encourages the Mayor to sub-name a portion of the street in the area of East 28th Street and Speakman Place as "Wilbert "Wilby" B. Fletcher Way."

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that City Council respectfully encourages the Mayor to designate a portion of the street in the area of East 28th Street and Speakman Place as "Wilbert "Wilby" B. Fletcher Way," in recognition of Mr. Fletcher's significant contributions to the City of Wilmington. City Council looks forward to joining the Administration in celebrating this designation.

Upon a motion of Council Member Guy, seconded by Council Members Williams and Freel, the above Resolution was before the Council for its consideration. Council Member Guy spoke on the purpose of the Resolution.

Council Members Oliver, Chukwuocha, Harlee, Turner and Williams and President Shabazz requested to be added as co-sponsors.

President Shabazz: Clerk will call the roll.

The Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Congo, Oliver, Harlee, Turner, McCoy, Williams, Freel, Adams and Guy, and Council President Shabazz. Total, ten. Nays, none. Absent, Council Members Chukwuocha, Dixon and Walsh. Total, three.

President Shabazz: Declare it adopted.
