FISCAL IMPACT STATEMENT: While there could be a higher cost associated with some inclusive playground and park equipment, these costs could be mitigated in other ways by strategically designing park construction and renovation projects, and could be offset by securing grant funding or forming public-private partnerships.

POLICY STATEMENT: This proposed Ordinance is designed to ensure an inclusive, accessible and positive environment in which our residents can experience the substantial benefits of parks and playgrounds. This legislation therefore codifies the city's expectation regarding the design of City parks and playgrounds. This Ordinance has been driven by research conducted on the topic and is largely modeled after the City of Philadelphia's Bill No. 160304, which requires all parks and playgrounds owned by the City to be more inclusive of individuals with special needs. This Ordinance is intended to enhance the quality of the life for residents and visitors of the City of Wilmington.

Upon a motion of Council Member Williams, seconded by Council Member Turner, the above Ordinance was before the Council for its consideration. Council Member Williams spoke on the purpose of the Ordinance.

President Pro Tempore Chukwuocha: Clerk will call the roll.

WHEREAS, AmeriCorps, a program of the Corporation for National and Community Service, engages with more than 80,000 people in voluntary public service work in sites including nonprofits, schools and public agencies; and

WHEREAS, by becoming involved with a coalition that supports community development and engagement, Wilmington can have access to more resources that will allow the City and its various programs to flourish and provide effective services to our residents and visitors.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, that Council supports the City in joining the Cities of Service coalition, and encourages the Administration to sign a Declaration of Service so that Wilmington can become involved in such a beneficial network of cities.

BE IT FURTHER RESOLVED that the Chief of Police, or his designee, shall be authorized to take all necessary actions to accept any and all funds associated with the grant application and to fulfill the grant requirements.

FISCAL IMPACT STATEMENT: There is no negative fiscal impact on the City, because no local matching funds are required by the grant.
