

**AN ORDINANCE TO ENACT CERTAIN TRAFFIC  
PARKING REGULATIONS.**

**WHEREAS**, pursuant to the City Charter and Chapter 37 of the City Code, the

**HEREBY ORDAINS:**

**SECTION 1.** That an “**ALL-WAY STOP**” signs be installed on Baynard Boulevard intersecting West 27<sup>th</sup> Street and North Franklin Street.

**SECTION 2.** That an “**ALL-WAY STOP**” signs be installed on North Orange Street intersecting West 3<sup>rd</sup> Street.

**SECTION 3.** That “**STOP**” signs be installed at the following locations:

- a. On Winchester Avenue at the intersection of North Tatnall Street.
- b. On Van Buren Street at the intersection of West 39<sup>th</sup> Street.
- c. On West 8<sup>th</sup> Street at the intersection of North Tatnall Street.

**SECTION 4.** That “**NO TURN ON RED**” signs be installed on West 7<sup>th</sup> Street eastbound at the intersection of North Lincoln Street.

**SECTION 5.** That “**NO PARKING ANYTIME BETWEEN SIGNS**” be installed at the following locations:

- a. On the southside of West 31<sup>st</sup> Street beginning 90 feet from the easterly building line of Washington Street and extending east 44 feet.
- b. On the southside of West 7<sup>th</sup> Street beginning 90 feet from the westerly building line of West Street and extending west 20 feet.

**SECTION 6.** That “**NO PARKING CHILD CARE DROP OFF 7:30 A.M. TO 5:30 P.M., Except Saturdays and Sundays**” signs be installed on the eastside of North Van Buren Street beginning 170 feet south of West 10<sup>th</sup> Street and extending south 40 feet.

~~\*SECTION 7. That “**NO PARKING LOADING ZONE 6:00 A.M. TO 3:00 P.M., Except Saturdays and Sundays, Between Signs**” signs be installed on the eastside of North Pine Street beginning 110 feet south of East 17<sup>th</sup> Street and extending south 80 feet.~~

**SECTION 8.** That “**FOUR-HOUR PARKING 8:00 A.M. TO 6:00 P.M., Except Saturdays and Sundays**” signs be installed on the eastside of South Tatnall Street, beginning at Water Street and extending south 415 feet.

**SECTION 9.** That “**TWO-HOUR PARKING 8:00 A.M. TO 6:00 P.M., Except Saturdays and Sundays**” signs be installed on the westside of North French Street beginning 30 feet from the southerly building line of East 10<sup>th</sup> Street and extending south 60 feet.

**SECTION 10.** That “**ONE-HOUR PARKING 8:00 A.M. TO 6:00 P.M., Except Sundays**” signs be installed on the eastside of North Union Street beginning 46 feet from the southerly building line of West 2<sup>nd</sup> Street and extending south 40 feet.


**SECTION 11.** That the portions of legislation that designates the following be hereby **RESCINDED**:

- a. Removal of “**NO PARKING 8:00 A.M. to 6:00 P.M. Between Signs**” signs on the eastside of North Van Buren Street beginning at the southerly building line of West 10<sup>th</sup> Street and extending south 170 feet.

- b. Removal of "TWO-HOUR PARKING 8:00 A.M. TO 6:00 P.M., Except Saturdays and Sundays Between Signs" signs on the eastside of South Tatnall Street, beginning at Water Street and extending south 415 feet.
- c. Removal of "NO PARKING 7:00 A.M. TO 5:00 P.M., Except Saturdays and Sundays" on the westside of Wilson Street between East 12<sup>th</sup> Street and East 13<sup>th</sup> Street.
- d. Removal of "TWO HOUR PARKING 8:00 A.M. TO 6:00 P.M., Except Sundays" signs on eastside of Van Buren Place between West 22<sup>nd</sup> Street and West 23<sup>rd</sup> Street.

**SECTION 12.** This ordinance shall become effective immediately upon its date of passage by the City Council and approval by the Mayor.


