**WHEREAS**, pursuant to the City Charter and Chapter 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to enact the traffic/parking regulations set forth herein.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF  
WILMINGTON HEREBY ORDAINS:**

**SECTION 1.** That an **“ALL-WAY STOP”** signs be installed on Oak Street intersecting South Dupont Street.

**SECTION 2.** That **“STOP”** signs be installed on North Union Street at the intersection of Delaware Avenue for northeast bound traffic.

**SECTION 3.** That **“NO PARKING HERE TO CORNER”** signs be installed on the eastside of Miller Road beginning at the southerly building line of West 30<sup>th</sup> Street and extending south 70 feet.

**SECTION 4.** That **“NO PARKING LOADING ZONE”** signs be installed on the westside of North King Street beginning 47 feet north of the northerly building line of West 7<sup>th</sup> Street and extending north 60 feet.

**SECTION 5.** That **“NO PARKING BUS STOP”** signs be installed on the southside of West 4<sup>th</sup> Street beginning as the easterly building line of North Shipley Street and extending east 40 feet for the use of Rockledge Bus Tours.

**SECTION 6.** That **“NO PARKING DART PARATRANSIT BUS STOP”** signs be installed on the northside of West 18<sup>th</sup> Street beginning at the east corner of Jefferson Street and extending south 30 feet.

**SECTION 7.** That “**NO PARKING URBAN SCHOOL STAFF PARKING 6:00 A.M. TO 6:00 P.M., EXCEPT SUNDAY**” signs be installed on the eastside of North Tatnall Street beginning at the southerly building line of West 6<sup>th</sup> Street and extending south 40 feet.

**SECTION 8.** That “**15 MINUTE PARKING 8:00 AM TO 6:00 PM, EXCEPT SUNDAYS**” signs be installed on the southside of West 10<sup>th</sup> Street beginning 20 feet east of the easterly building line of North Orange Street and extending east 54 feet.

**SECTION 9.** That “**15 MINUTE CHILD DROP OFF AND PICK UP 7:00AM TO 6:00 PM, EXCEPT SATURDAYS AND SUNDAYS**” signs be installed on the eastside of North Walnut Street beginning 26 feet from the northerly building line of West 7<sup>th</sup> Street and extending north 43 feet.



**SECTION 10.** That the portions of legislation that designates the following be hereby **RESCINDED**:


- a. Removal of “**NO PARKING LOADING ZONE 8:00 AM TO 6:00 PM, Except Sundays**” on the southside of West 10<sup>th</sup> Street beginning 20 feet east of the easterly building line of North Orange Street and extending east 54 feet.

**SECTION 11.** This substitute ordinance shall become effective immediately upon its date of passage by the City Council and approval by the Mayor.
