AN ORDINANCE TO AMEND CHAPTER 2 OF THE CITY CODE REGARDING PROCEDURES TO FILL CITY COUNCIL VACANCIES

Council Member Harlee WHEREAS, the City Council deems it necessary and proper to amend the provisions of Section 2-34 of the City Code regarding the procedures to fill City Council vacancies; and

WHEREAS, Section 2-101 of the City Charter states that if a vacancy occurs in the period less than thirty (30) days before the date of a primary election or pending the election of a councilman to fill a vacancy, the City Council, by a majority vote of all its remaining members, shall appoint a person to fill the vacancy until a person is elected by the voters for the unexpired term; and

WHEREAS, the City Charter does not clearly provide procedures for how Council appoints a person to fill the vacancy, and Section 2-34 of the City Code provides for such procedures; and

WHEREAS, City Council wishes to change the procedures by which Council appoints a person to fill the vacancy by increasing the ability for all members of Council to be involved in recommending an individual to Council to fill the vacancy.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF WILMINGTON HEREBY ORDAINS:

SECTION 1. Chapter 2 of the City Code is hereby amended by amending Section 2-34 thereof by deleting the stricken language and adding the underlined language to read as follows:

§ 2-34. - Procedures to fill city council vacancies.

1.

The city council hereby establishes the following procedures by which a person is appointed by resolution to fill a city council vacancy:

The president of city council shall appoint members of a special committee eonsisting of five members of city council; one member shall be the president who shall serve as its chair. The special committee The committee of the whole of city council, chaired by the president of city council, shall be charged with selecting a candidate to fill the vacancy in accordance with the requirements outlined in the City Charter section 2-101.

- (1) The special committee of the whole shall:
 - a. Accept recommendations from members of council in accordance with the requirements of subsection (1)b of this section;
 - Accept resumes and letters of intent, during a specified time period, from persons who are qualified pursuant to the City Charter;
 - c. Interview each qualified person in executive session;
 - Each member of the committee of the whole shall identify the top three candidates to fill the vacancy. The candidates shall be identified using an identifier, other than the candidate's name, which will be assigned to each candidate during executive session.
 - d. b. Recommend a person by majority vote of the members of the special committee of the whole; and
 - e. e. Follow the requirements for appointment of a person to fill a council vacancy, pursuant to the City Charter.
- (2) The vacancy shall be certified by resolution.
- (3) The special committee of the whole shall propose by resolution its recommendation of a person to fill the vacancy for vote by the full of city council. The resolution must be approved by a majority vote of all the members of city council.
- (4) If the resolution fails to be approved, the committee of the whole shall reconvene and propose by resolution another recommendation of a person who it previously interviewed to fill the vacancy for a vote by the full of city council. The resolution must be approved by a majority vote of all members of city council. The committee of the whole shall repeat this procedure until the vacancy is filled.
- (5) While the procedures set forth in this section are taking place, if the city council vacancy is for a councilmanic district, the at-large council member

living in or closest to the district in which there is a vacancy will respond to and assist residents in that district until the vacancy is filled.

SECTION 2. This Ordinance shall become effective upon its passage by City Council and approval by the Mayor.

SYNOPSIS: This Ordinance amends Section 2-34 of the City Code, which sets forth procedures to fill City Council vacancy, by allowing all members of Council to be part of the committee that recommends to Council an individual to fill a Council vacancy.

POLICY STATEMENT: This Ordinance is intended to change the procedures by which Council appoints a person to fill a vacancy on the legislative body, in an effort to clarify procedures and make the process more inclusive of all members of City Council. This Ordinance also lays out the various stages of the process for filling a Council vacancy with the intent of clarifying this process, as well as ensuring it flows smoothly and each candidate receives equal treatment and consideration — with steps taken to ensure confidentiality, the same questions being asked of each candidate, and a clear, codified process for expressing interest and being considered to fill a vacancy on City Council.

WHEREAS, the Council Member elected from the First Councilmanic District, Nnamdi O. Chukwuocha was elected on November 6, 2018 to the Delaware House of Representatives during the General Election; and

WHEREAS, pursuant to the Delaware Constitution, Schedule Section 4, his term of office as Representative began November 6, 2018, which also prohibits his from holding an incompatible office during his term of office as a Representative; and

WHEREAS, Council Member Nnamdi O. Chukwuocha has decided that she should resign his office as the First Councilmanic District's Council Member in order to take office as a State Representative; and

WHEREAS, Council Member Chukwuocha submitted a letter of resignation from the Wilmington City Council to Council President Shabazz who accepted it with sincere regret; and

WHEREAS, Council Member Chukwuocha's resignation was effective on November 6, 2010; and

WHEREAS, pursuant to the Wilmington City Charter, Chapter 2, <u>Wilm. C.</u> (Charter) \$2-101, when such vacancy occurs between General Elections, it is the duty of City Council to fill said vacancy with a member of the same political party residing in the same council district in which such vacancy occurs for the un-expired term of the resigning Council Member; and

WHEREAS, pursuant to <u>Wilm</u>. <u>C</u>. (Charter) \$2-103, the City Council is empowered to be the "sole judge of the qualifications. . . of its members" and an Ad hoc Committee of City Council has unsuccessfully recommended a replacement to fill the vacancy in the First City Council District seat.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE

CITY OF WILMINGTON, that the Council hereby certifies that the First District City Council seat is vacant due to the resignation of Council Member Nnamdi O. Chukwuocha on November 6, 2018 due to his election to the Delaware House of Representatives.

BE IT FURTHER RESOLVED, that the City Council hereby appoints Subira Ibrahim, a duly registered member of the Democratic Party residing in the First Councilmanic District of the City of Wilmington, to fill the vacancy created by the aforesaid resignation of Council Member Nnamdi O. Chukwuocha, for the remainder of Council Member Chukwuocha's term.

Council Member Dixon Freel WHEREAS, public participation in the electoral process is a fundamental principle of democratic governance, strengthening citizens' trust in authorities, and achieving better governance; and

WHEREAS, unaffiliated and third-party voters are the fastest-growing segments of the Delaware electorate — accounting for nearly 160,000 residents that identify with neither political party; and

WHEREAS closed political primaries disenfranchise thousands of Wilmington's non-Democratic voters, disregarding their voice in the selection of our leaders. As Wilmington's voters are overwhelmingly registered Democrats, the candidate who wins the primary often is the de facto winner of the general election since there is no candidate from the opposing party to challenge them; and

WHEREAS, many other communities – including more than 80% of the U.S.'s 50 largest cities with elected mayors – avoid this problem by having some form of a nonpartisan primary election. Adopting this approach ensures that all voters maintain a say in who governs them and prevents a candidate from being elected without genuine support from a majority of voters; and

WHEREAS, moving to a nonpartisan primary system is an option that Wilmingtonians deserve a chance to consider for themselves. Accordingly, State law should be adjusted to allow Wilmington to adopt this more inclusive system through a charter amendment.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE

CITY OF WILMINGTON, that the City Council encourages the Delaware General Assembly to enact legislation authorizing the City of Wilmington to adopt a nonpartisan primary election system, allowing unaffiliated voters to participate in any party primary they choose.

SYNOPSIS: This Resolution urges the Delaware General Assembly to enact legislation authorizing Wilmington City Council to adopt a more comprehensive, nonpartisan primary election system to ensure inclusive and democratic elections for City officials.
