Academics & Equity Updates

Academics and Equity – Phase I

- The Academics and Equity Committee continues to provide recommendations for hybrid and virtual school reopening this fall.
- Considerations for schools:

Before Learning

Rapid identification academic, social, emotional and basic needs, designing professional learning and planning for intervention.

During Learning

Prioritizing curriculum, creating sample schedules, and ensuring ample time for intervention

After Learning

Identifying academic, social, emotional and community outreach and supports for students, families and staff as they navigate the virtual learning space.

Academics and Equity – Phase II

- Prioritized district curriculum in all content areas to support learning in the virtual space.
- Launched a series of professional learning for our newly adopted Learning Management System.
- Delivered Train the Trainer professional learning modules from Modern Teacher Framework to representatives from each school campus.
- Purchased Pro Zoom accounts for all school personnel.



Academics and Equity

- Established a new attendance policy for the virtual space.
- Transferred our Student/Family Services material to an online platform including the ability to sign electronically.
- Worked closely with our Technology department to prep all available devices while awaiting the delivery of additional inventory (including hot spots).
- Created plans to contact every family and provide programming for those who do not have devices.


Academics and Equity

- Identified universal screeners to rapidly identify learning needs in the first days/weeks of school.
- Established Extra Time programming to offer extra support and/or enrichment for all students.
- Worked with community partners to establish Learning Pods throughout the communities of Newark and Wilmington.
- Created partnerships with community based organizations to partner and provide additional supportive opportunities for students and their families.

Christina School District Virtual Academy

- Is there a Need for the CSDVA?
- July CSD Parent Survey
 - 39% of families indicated they would not send their students back to school this fall, even with Governor approval and state recommended safety precautions.
- New Non Public Schools in Delaware
 - 563 new non public schools have been registered
 - 877 total students
- >1,000 families sought enrollment in the first 72 hours

Operations and Services Updates

Operations and ServicesFocus on Increasing Equity & Access

Technology

- Build on Christina's 1:1 plan and roll out to all grades
- Provide devices to Special Programs that meet the unique technology needs of students and staff
- Invest in cameras that allow remote access to classroom teaching
- Acquire hotspots to address Internet connectivity issues
- Tech teams have been created at each school to provide enhanced support for students, families, and staff

Nutrition

- Expanded remote meal access by providing bus delivery to high-need communities in addition to curbside pickup (21 sites)
- USDA approved continued funding for free meals for all children 18 and younger through December 31st or until federal funding for this program runs out

Operations and ServicesFocus on Increasing Equity & Access

Transportation

- Three buses (ES, MS, and HS) did trial runs to determine time and supplies needed to disinfect, the impact on additional time needed between runs, and impact on bell times
- Cleaning supplies and PPE acquired
- Two cleaning models
 - Routine cleaned with EPA-approved disinfectant between every run
 - Targeted routine, plus foggers used in suspected/confirmed exposure and during long weekends or breaks
- Constraints around transportation remain one of the major challenges to returning in a hybrid or traditional model

Safe Buildings for Staff and Students


CDC recommendations to create a safe and healthy building for staff, students, and the public.

- Increase fresh air entering the building
- Improve air filtration
- Purify recirculated air

Expert Engineers inspected CSD air dampers and facilities to provide recommendations for optimal settings.

Facilities Goals

- To have our students and staff return to clean and safe buildings.
 We have accomplished this goal by deep cleaning our buildings.
- In the case of a reported presumed positive person, minimize the spread of the virus to others. There are three parts to our response:
 - Providing PPE to staff and students
 - Disinfecting surfaces where the presumed positive person travelled
 - Operate our ventilation and air purification systems in a way that minimizes the spread of the virus to others



Health and Wellness

- Staff COVID-19 Testing
 - 2,650 unique URL's have been distributed
- Student Testing Tentative
 - 3 Locations GHS, Kirk, and Drew
 - October 8, 9, and 12
 - 15-20 volunteers per day/site
 - Collaborative effort with DEMA,
 NCC, and CSD

- Isolation Rooms in 12 CSD schools
- Educational COVID-19 videos produced for staff and students
- Developed a Framework to track CSD positive COVID-19 staff and students
- DPH Pediatrician available for consult
- Community participation (Food Bank, COVID Testing)

Special Populations Update

Action steps for the development of a hybrid instructional model for students of special programs.

Coordination with DPH

- Keeping committee up-to date with changes in CDC guidelines
- Reviewing evidence-based guidance for protocol development with medical professionals
- Communicating possible needs for support in maintaining appropriate levels of appropriate PPE

Identifying Barriers/ **Solutions**

- Partnering with other district's special services committees to discuss processes for similar challenges
- Focusing the greatest challenges:
 - Lack of student mask wearing
 - Difficulty for staff to physical distance and still provide instructional supports

Educating Stakeholders

- Developing and implementing staff training
- Educating families on protocols and their role in preparing their child for in-person instruction
- Educating students on masking, physical distancing and hand hygiene
