An Ordinance to Amend Chapter 2 of the City Code to Require Annual Ethics Training and to Revise the Procedure to Amend the City Ethics Requirements (1st & 2nd Reading)

Synopsis:

This Ordinance is being presented by City Council for Council's review and approval. This Ordinance amends Chapter 2 of the City Code to require all Elected Officials, Appointed Officials, and City Employees to attend an ethics training presentation approved by the Wilmington Ethics Commission or view a recorded ethics training presentation approved by the Wilmington Ethics Commission on an annual basis. In addition, this Ordinance creates a new procedure for amending the City's ethics rules to provide an opportunity for the Wilmington Ethics Commission to review and make recommendations on such proposed amendments. Finally, as a housekeeping matter, this Ordinance deletes some language from and adds some language to City Code Section 2-345(a) to clarify the jurisdiction of the Wilmington Ethics Commission as established by City Code Section 2-343.
