My entire Administration remains dedicated to making sure that when our time in office comes to a close, Wilmington and the people of this City are in a better position of opportunity, prosperity and equality than they were when we arrived in 2017. The priority of all of us in elected office should be to improve the overall quality of life for everyone.

I am looking forward to a new chapter in our working relationship with City Council. I am confident that this new session will bring about an elevated level of dialogue, understanding, cooperation and achievement for both the Administration and Council. I pledge to Council President-elect Congo and to each member of the 108th Council Session, my undivided attention to their concerns and those of their constituents.
