

AN ORDINANCE TO ENACT CERTAIN TRAFFIC AND PARKING REGULATIONS

WHEREAS, pursuant to the City Charter and Chapter 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to enact the traffic and parking regulations set forth herein.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF WILMINGTON
HEREBY ORDAINS:**

SECTION 1. That an “**ALL-WAY STOP**” sign be installed at the following locations:

- a. Northbound West 9th Street & North Bancroft Parkway
- b. Southbound West 9th Street & North Bancroft Parkway

SECTION 2. That a “**NO PARKING STREET CLEANING MONDAYS 11:00 AM TO 1:00 PM**” sign be installed at the following locations:

- a. Westside of the 300 block of North Lombard Street
- b. Southside of the 400 block of East 4th Street
- c. Southside of the 500 block of East 4th Street

SECTION 3. That “**NO PARKING LOADING ZONE 8:00 AM TO 6:00 PM, DAILY**” signs be installed on the northside of West 4th Street, beginning 102 feet from the westerly building line of North Monroe Street and extending east 20 feet.

SECTION 4. That “**NO PARKING ANYTIME BETWEEN SIGNS**” signs be installed on the westside of North Rodney Street, beginning at the northerly building line of Shallcross Avenue and extending north 50 feet.

SECTION 5. That “**15 MINUTE PARKING 8:00 AM TO 4:00 PM, EXCEPT SATURDAYS AND SUNDAYS BETWEEN SIGNS**” signs be installed on the westside of

Maryland Avenue, beginning 30 feet from the southerly building line of Sycamore Street and extending south 40 feet.

SECTION 6. That “**NO PARKING CHILD DROP OFF & PICKUP 7:00 AM TO 5:00 PM, EXCEPT SATURDAYS AND SUNDAYS**” signs be installed on the westside of North Market Street, beginning at the intersection of Gordon Street and extending north 40 feet.

SECTION 7. That “**NO PARKING CHILD DROP OFF & PICKUP 6:30 AM TO 4:00 PM, EXCEPT SATURDAYS AND SUNDAYS**” signs be installed on the Southside of Cedar Street between South Broom Street and South Franklin Street.

SECTION 8. That the portions of legislation that designate the following be hereby **RESCINDED** to allow for the **REMOVAL** of signs as stated herein:

- a. “**2 HOUR PARKING 8:00 AM TO 6:00 PM, EXCEPT SATURDAYS AND SUNDAYS**” signs on the eastside of North Lombard Street between East 7th Street and East 8th Street.
- b. “**2 HOUR PARKING 8:00 AM TO 6:00 PM, EXCEPT SATURDAYS AND SUNDAYS**” signs on the northside of East 7th Street beginning at the westerly building line of North Lombard Street and extending west 150 feet.
- c. “**NO PARKING BUS STOP BETWEEN SIGNS**” signs be removed from the following locations:
 - i. On the westside of North Tatnall Street beginning at the intersection of West 42nd Street and extending north 60 feet.

SECTION 9. This Ordinance shall become effective immediately upon its passage by City Council and approval by the Mayor.
