WHEREAS, in *The Productivity of Working Hours*, STANFORD INSTITUTE FOR ECONOMIC POLICY RESEARCH (2013), the author states that an employee working more hours does not automatically equate to an increase in quantity of work completed because fatigue and stress result in decreased productivity; and

WHEREAS, as expressed in *An Assessment of Paid Time Off in the U.S.*, OXFORD ECONOMICS (2014), allowing time for one to take vacation and recharge is necessary to prevent burnout and increase employee productivity; and

WHEREAS, in ENVIRONMENT INTERNATIONAL 154 (2021), the World Health Organization and International Labour Organization found that working long hours is a common contributor to increased health concerns; and

WHEREAS, 22 *Del. Code* § 811 permits the City Charter to “be amended by act of the General Assembly, passed with the concurrence of two thirds of all the members elected to each House thereof”; and

WHEREAS, consistent with Part III, Chapter 2, Section 3(B) of the *Delaware Legislative Drafting Manual* (2019 ed.), the Wilmington City Council has attached a draft proposed General Assembly bill as *Attachment A*.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington City Council urges the Delaware General Assembly to amend City Charter § 2-204 to exclude August and December from the twice-a-month meeting requirement except when a meeting is requested by the Mayor, President of City Council, or a Majority of the City Council.

AN ACT TO AMEND SECTION 2 OF THE CITY OF WILMINGTON HOME RULE CHARTER TO EXCLUDE AUGUST AND DECEMBER FROM THE TWICE-A-MONTH MEETING REQUIREMENT EXCEPT WHEN A MEETING IS REQUESTED BY THE MAYOR, PRESIDENT OF CITY COUNCIL, OR A MAJORITY OF THE CITY COUNCIL.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE
(Two-thirds of all members elected to each house thereof concurring therein

1 Section 1. Amend Article II, Chapter 1, Section 2-204 of the City of Wilmington Home Rule

2 Charter by making deletions as shown by strike though and insertions as shown by underline as
3 follows:

4 **Wilmington City Charter, Sec. 2-204. Council meetings.**

5 The meetings of the council shall be open and at all times accessible to the public. Official city
6 business transacted by the city council shall be in the public meetings. The city council shall meet
7 regularly at least twice in each month-, except in the months of August and December when no
8 meetings shall be held unless a special meeting is called pursuant to this section. The time, place and
9 date of regular and the places of special meetings shall be established by the city council as a part of
10 the rules of procedure adopted for the conduct of its meetings. Special meetings may be held on the
11 call of the mayor, or the president of city council, or of a majority of the members of the city council
12 in accordance with rules adopted as a part of the rules of procedure of the city council. A majority of
13 all members of the council including the president of the council shall constitute a quorum, but a
14 smaller number may adjourn from time to time and may compel the attendance of absent members
15 in the manner and subject to the penalties prescribed by the rules of the city council.

16 Section 2. This enactment shall be effective after signature by the Governor.
