AN ORDINANCE TO ENACT CERTAIN PARKING REGULATIONS

WHEREAS, pursuant to the City Charter and Chapter 37 of the City Code, the Department of Public Works has proposed and the City Council deems it necessary and proper to enact the parking regulations set forth herein.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF WILMINGTON HEREBY ORDAINS:

SECTION 1. That a "Bus Stop" sign be erected at the following locations:

- a. West 8th Street & North Jefferson
- b. West 9th Street & North West Street
- c. West 8th Street & 801 North West Street
- d. East 9th Street & Clifford Brown Walk
- e. 411 East 8th Street & North Lombard Street
- f. North Orange Street & 6th Street

SECTION 2. That "2 HOUR PARKING 8:00 AM TO 6:00 PM, EXCEPT SATURDAYS AND SUNDAYS" signs be installed at the following locations:

- a. On the west side of North Orange Street between West 7th Street and
 West 8th Street
- On the east side of North Orange Street between West 5th Street and
 West 9th Street

SECTION 3. That the portions of legislation that designate the following be hereby **RESCINDED** to allow for the **REMOVAL** of signs as stated herein:

a. That a "Bus Stop" sign be removed from West 8th Street & Morrow Street

- That a "Bus Stop" sign be removed from West 9th Street & Madison
 Street
- c. That a "Bus Stop" sign be removed from West 9th Street & North
 Washington Street
- d. That a "Bus Stop" sign be removed from West 8th Street & North
 Washington Street
- e. That a "Bus Stop" sign be removed from West 8th Street & 800 North

 West Street
- f. That a "Bus Stop" sign be removed from West 8th Street and North
 Orange Street
- g. That a "Bus Stop" sign be removed from East 9th Street and North
 Walnut Street
- h. That a "Bus Stop" sign be removed from East 9th Street and North

 Lombard Street
- That a "Bus Stop" sign be removed from East 8th Street and 800
 North Lombard Street
- j. That a "Bus Stop" sign be removed from East 9th Street and North

 Pine Street
- k. That a "Bus Stop" sign be removed from North Orange Street betweenWest 5th Street and West 6th Street
- 1. That "NO STOPPING STANDING OR PARKING" signs be removed from the west side of North Orange Street between West 7th Street and West 8th Street

m. That "NO STOPPING STANDING OR PARKING" signs be removed from the east side of North Orange Street between West 5th Street and West 9th Street

SECTION 4. This Ordinance shall become effective immediately upon its passage by City Council and approval by the Mayor.
