Fields, Johnson, N. Field, Cabrera, Mills, Spadola and Walsh, and Council President Congo. Total, eleven. Nays, none. Absent, Council Members Gray and McCoy. Total, two.

President Congo declared the Resolution adopted.

Council Member B. Fields did not have any legislation to present this evening. President Congo stated that Agenda #0146 was being held.

Council Member Johnson presented and called for the first and second reading Ordinance No. 22-012 (Agenda #0147) entitled:

AN ORDINANCE TO AUTHORIZE AND APPROVE A SERVICE AGREEMENT BETWEEN THE CITY OF WILMINGTON AND VERIZON DELAWARE LLC FOR N11 DIALING SERVICE FOR VERIZON'S TELEPHONE EXCHANGE END-USER SUBSCRIBERS

FISCAL IMPACT STATEMENT: The fiscal impact of this Ordinance is a month-to-month contract with a price not to exceed Five Thousand Dollars (\$5,000.00) per year.

The above-referenced Ordinance was given two separate readings by title only and upon a motion of Council Member Johnson, seconded by Council Member B. Fields, the Ordinance was received, recorded and referred to the Finance & Economic Development Committee. Motion prevailed.

Council Member N. Field did not have any legislation to present this evening.

Council Member Cabrera presented <u>Resolution No. 22-012</u> (Agenda #0148) as follows:

WHEREAS, 20 Del. C. § 3142-a (1) creates a health emergency commission that develops a public health emergency plan to be revisited every two years. The commission's original purpose included developing a "plan that ensures that 90% of the population is covered by a health alert network"; and

WHEREAS, Delaware's current emergency notification system is mainly dependent on landline-based notifications, which is primarily utilized only by 6.5% of the United States population on average. Additionally, wireless cellular devices are the only phone communication used by 62.5% of adults and 73.8% of children. Only 3% of Delawareans have manually registered with the States Emergency Notification System of those participating in wireless-only communication; and

WHEREAS, Wireless Emergency Alert System uses geographically targeted messaging to all available devices near emergency inducing incidents, ensuring high alerts are communicable and relevant to recipients; and

WHEREAS, catastrophic events are defined as having severe health consequences to the health and safety of public health, and alerts need to reach the most significant number of people as fast as possible; and

WHEREAS, 13% of the United States population speak Spanish primarily at home.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington City Council supports House Bill 259 and its incorporation of the use of the Federal Wireless Emergency Alert, in both English and Spanish, to reach the highest percent of the population as quickly as possible in catastrophic situations.

Upon a motion of Council Member Cabrera, seconded by Council Members Walsh and B. Fields, the Resolution was before the Council for its consideration. Motion prevailed. Council Member Cabrera made comments.

President Congo requested the Clerk to call for the roll.

The above-referenced Resolution was received, adopted as read and directed to be recorded and filed by the following Yea and Nay Roll Call Vote: Yeas, Council Members Darby, Oliver, Harlee, B. Fields, Johnson, N. Field, Cabrera, Mills, Spadola and Walsh, and Council President Congo. Total, eleven. Nays, none. Absent, Council Members Gray and McCoy. Total, two.

President Congo declared the Resolution adopted.

Council Member Spadola did not have any legislation to present this evening.

Council Member Walsh presented <u>Resolution No. 22-013</u> (Agenda #0149)

as follows:

WHEREAS, pursuant to Section 2-363 of the City Code, City Council deemed it necessary and proper to specify the requirements for review and approval of City-sponsored grant applications and proposals, including authorization for expedited grant applications when necessary prior to Council's approval by resolution; and

WHEREAS, the Office of Emergency Management (the "Office") submitted a grant application for the 2021 Emergency Management Performance Grant ("EMPG"), Supplemental American Rescue Plan Act ("ARPA"), a pass-through grant from the Federal Emergency Management Agency to the Delaware Emergency Management Agency, supplemented with funding provided by the ARPA, in the amount of \$36,000.00; and

WHEREAS, the purpose of the EMPG program is to provide federal funding to assist state and local governments in preparing for all hazards by implementing the national preparedness system and the national preparedness goal of a secure and resilient nation; and

WHEREAS, the Office intends to use the grant monies to support the administration and operation of the Office, including personnel salaries and benefits, supplies, equipment, services, maintenance and upkeep of the Emergency Operations Center, and expenses incurred during the activation of the Emergency Operations Center; and

WHEREAS, the City is required to provide matching funds of fifty percent (50%) of the total cost of the project which will not exceed \$72,000.00, thereby creating a local match requirement of up to \$36,000.00; and

WHEREAS, the City will fund this match requirement with amounts already budgeted for this purpose; and

WHEREAS, City Council deems it necessary and appropriate to authorize the grant application for the aforesaid purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Office of Emergency Management's grant application to the Delaware Emergency Management Agency in the amount of \$36,000.00 is hereby authorized.

BE IT FURTHER RESOLVED that the Director of the Office of Emergency Management, or his designee, shall be authorized to take all necessary actions to accept any and all funds associated with the grant application and to fulfill the grant requirements.

FISCAL IMPACT STATEMENT: There is no negative fiscal impact to the City. Although the grant requires a fifty percent (50%) local match of the total cost of the project up to a maximum match of \$36,000.00, sufficient funds have already been budgeted within the Office of Emergency Management for this purpose.

Upon a motion of Council Member Walsh, seconded by Council Member B. Fields, the Resolution was before the Council for its consideration. Motion prevailed. Council Member Walsh spoke on the purpose of the Resolution.

President Congo requested the Clerk to call for the roll.

President Congo declared the Resolution adopted.
