WHEREAS, the City would like to accept the donation of the Easements from RDC to perform the Maintenance; and

WHEREAS, City Council, upon the recommendation of the Department of Public Works, wishes to authorize the City to accept the donation of the Easements.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITYOF WILMINGTON that Council hereby authorizes the City to accept the donation of the Easements, as more particularly described in the agreements attached hereto and incorporated herein as Exhibit A, from the RDC.

of the Marine Unit when responding to calls for service and conducting water rescues or searches; and

WHEREAS, proposed grant funding in the amount of \$10,000.00 would allow for the replacement of a trailer used to transport bicycles and other equipment for special operations. The department's current trailer is more than 12 years old and is in disrepair; and

WHEREAS, proposed grant funding in the amount of \$69,500.00 would allow for the replacement of two Unmanned Aerial Vehicles - including batteries, accessories and warranties - as well as communication headsets, to be utilized by the Forensic Services Unit in connection with investigations and special events; and

WHEREAS, proposed grant funding in the amount of \$3,600.00 would be used to purchase electronic hearing protection equipment with enhanced noise reduction capabilities for use by officers while completing State-mandated training and firearms qualifications at the department's range; and

WHEREAS, this grant funding would cover expenses that would otherwise have to be absorbed by the Police Department's annual budget, continuing the Police Department's efforts to identify funding opportunities to offset increases to the City budget; and

WHEREAS, no matching funds are required; and

WHEREAS, the Council deems it necessary and proper to authorize the grant application, for the aforesaid purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington Police Department's grant application to the State of Delaware in the total amount of \$97,600.00 is hereby authorized.

BE IT FURTHER RESOLVED that the Chief of Police, or designee, shall be authorized to take all necessary actions to accept any and all funds associated with the grant application and to fulfill the grant requirements.

FISCAL IMPACT STATEMENT: There is no negative fiscal impact to the City because no local matching funds are required by this grant.

This protective equipment ensures the safety of officers responding to calls involving armed, barricaded subjects, as well as hostage situations and active shooter situations. This grant would support the replacement of existing ballistic vest equipment that has reached the end of its lifecycle and is no longer effective; and

WHEREAS, proposed grant funding in the amount of \$35,992 would allow for the purchase of two forensic workstations and one forensic laptop, which would support investigations; and

WHEREAS, proposed grant funding in the amount of \$10,000 would support the purchase of a portable training facility to support ongoing training for police officers. This trailer includes a mock structure that can be used to facilitate a variety of trainings; and

WHEREAS, proposed grant funding in the amount of \$4,500 would allow for the purchase of 12 inflatable devices that can be deployed from land during a water rescue incident; and

WHEREAS, this grant funding would cover expenses that would otherwise have to be absorbed by the Police Department's annual budget, continuing the Police Department's efforts to identify funding opportunities to offset increases to the City budget; and

WHEREAS, no matching funds are required; and

WHEREAS, the Council deems it necessary and proper to authorize the grant application, for the aforesaid purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Wilmington Police Department's grant application to the State of Delaware in the total amount of \$205,492.00 is hereby authorized.
