#0407 A Resolution Issuing a Public Reprimand of Council Member Zanthia Oliver

for City of Wilmington Ethics Violations

Synopsis: This Resolution is being presented by City Council for Council's review and

approval. This Resolution issues a public reprimand to Councilwoman Zanthia Oliver for a second ethics violation found by the Wilmington Ethics Commission. It further informs the public of the steps City Council has taken to regain the

public trust.

#0408 A Resolution Requesting a Comprehensive Assessment of the Impact of Red-

Light Camera Ticketing on the Safety and Equity of City Residents

Synopsis: This Resolution is being presented by City Council for Council's review and

approval. Nationally, the use of red-light camera programs has declined, along with public support of such programs, due to concerns about disparate impacts on minority communities. This Resolution urges the Administration to make the necessary budgetary appropriations to commission a professional consultant to assess the safety and equity impacts of the City's red light ticket program by

December 31, 2024.

#0409 A Resolution for an Audit of Parking Tickets, Towing, and Booting

Synopsis: This Resolution is being presented by City Council for Council's review and

approval. The Wilmington City Council 2022-2025 Strategic Plan lists "Parking Enforcement" as an essential component of maintaining a "Resident and Visitor Friendly Wilmington." In furtherance of that goal, this Resolution encourages the Administration and relevant departments to conduct a comprehensive audit of parking tickets, towing, and the booting process before December 31, 2024.

#0213 Sub. 1 Ord. 22-033 Amend Chapter 45 of the City Code to Establish an Affordable

Water Program (3rd & Final Reading)

Synopsis: This Substitute Ordinance is being presented by City Council for Council's review

and approval. This Substitute Ordinance amends Chapter 45 of the City Code to require the Department of Finance to propose an Affordable Water Program, and

to present its findings to City Council by January 1, 2025.

#0344 Sub. 1 Ord. 23-034 Amend Chapter 45 of the City Code to Exempt Elderly and

Disabled Residents and Residences with Children Under the Age of Five from the Water Service Disconnection for Nonpayment of Utility Charges (3rd & Final Reading)

Synopsis:

This Substitute Ordinance is being presented by City Council for Council's review and approval. This Substitute Ordinance exempts eligible elderly and disabled residents as well as residences with children under the age of five from having water shut off for nonpayment of water service charges.

#0392 Sub. 1 Ord. 24-007 Amend Chapter 45 of the City Code to Prohibit the Department of

Finance from Including Arrearage of Unpaid Water, Sewerage, and Stormwater Fees and Related Costs in Monitions Action Against Customers that are Owner-Occupants (3rd & Final Reading)

Synopsis:

This Substitute Ordinance is being presented by City Council for Council's review and approval. This Substitute Ordinance amends Chapter 45 of the City Code to prohibit the Department of Finance from instituting monitions actions against City utility customers whose debts consist solely of unpaid water, sewerage, and stormwater fees, interest, penalties, and costs. This Substitute Ordinance shall become effective on July 1, 2024.

A Resolution Appointing the Members of the Residency Taskforce Pursuant Substitute No. 2 to Ordinance No. 23-040, As Amended

Synopsis:

This Resolution is being presented by City Council for Council's review and approval. Pursuant Substitute No. 2 to Ordinance No. 23-040, as amended, this Resolution appoints the members of the Residency Taskforce. These members include one (1) member from the Department of Human Resources, one (1) member of the Administration, and five (5) members of the public who reside in the geographical boundaries of the City of Wilmington. The members of the Taskforce will submit a final Report, no later than July 1, 2024, with recommendations on attracting residents to fill City vacancies and easing barriers to residencies for new hires to City employment.

This Ordinance is being presented by the Administration for Council's review and approval. This Ordinance authorizes the removal of a portion of Wilson Street, located between East Twelfth and Thirteenth Streets, and two unnamed alleys, located between Wilson Street and Clifford Brown Walk, from the Official City Map.

An Ordinance to Approve the Major Subdivision Plan Submitted by Vandemark & Lynch, Inc., on Behalf of St. Cyprian's Holdings, LLC, and to Authorize the Removal of a 0.175-Acre Segment of Right-of-Way Located at the Terminus of East Eighth Street from the Official City Map (1st & 2nd Reading)

Synopsis:

This Ordinance is being presented by the Administration for Council's review and approval. This Ordinance approves the major subdivision plan submitted by Vandemark & Lynch, Inc., on behalf of St, Cyprian's Holdings, LLC, and authorizes the City to remove a 0.175-acre segment of right-of-way located at the terminus of East Eighth Street from the Official City Map.

A Resolution Approving Grant Funds to the City of Wilmington Park's and Recreation Department

Synopsis:

This Resolution is being presented by City Council for Council's review and approval. This Resolution approves grant funding to the City's Department of Parks and Recreation Department from City Council Member's Community Support Discretionary Funds totaling \$8,825 for the skate program event and support for students to attend college tour.

A Project Ordinance Approving and Authorizing the Financing of a Project for Salesianum School, Inc.; Making Certain Findings with Respect Thereto; Authorizing the Issuance of City of Wilmington Revenue Bonds in an Aggregate Principal Amount Not to Exceed \$10,000,000; and Authorizing Other Necessary Action (1st & 2nd Reading)

Synopsis:

This Ordinance is being presented by the Administration for Council's review and approval. This Ordinance authorizes the City to issue tax-exempt and/or federally taxable revenue bonds (the "Bonds") for the financing of a project for Salesianum School, Inc. (the "School"). The Bonds will be special revenue obligations of the City, payable exclusively from (i) payments made by the School under a bond purchase and loan agreement entered into between the School and a lender selected by the School, (ii) a promissory note executed by the School and delivered to the City in the aggregate amount of the Bonds, and (iii) available funds under a limited continuing guaranty from OSFS Real Estate Trust, a Delaware charitable trust.

Ord. 24-010 Approve Amendments to the Large-Scale Redevelopment Project Known as "The Wilmington Flats" (**Public Hearing** – **postponed from April 4**th **meeting, and 3**rd & **Final Reading**)

Synopsis:

This Ordinance is being presented by the Administration for Council's review and approval. This Ordinance approves Woodlawn Trustees, Inc.'s application for amendments to the site plan for the large-scale redevelopment project known as "The Wilmington Flats".
