President Congo mentioned a change in the order of the agenda.

Council Member Johnson presented and called for the third and final reading Ordinance No. 24-001 (Agenda #0376) entitled:

AN ORDINANCE CONSTITUTING AMENDMENT NO. 2 TO THE FISCAL YEAR 2024 OPERATING BUDGET (BEING AN ORDINANCE TO AMEND ORDINANCE NO. 23-030)

SYNOPSIS AND FISCAL IMPACT STATEMENT: This Ordinance is the second amendment to the Fiscal Year 2024 Operating Budget, which was originally enacted in Substitute No. 1 to Ordinance No. 23-012 and was amended and restated in its entirety in Ordinance No. 23-030. This amendment appropriates \$3.5 million to pay for ambulance services for the city for the remainder of Fiscal Year 2024. The appropriation will be funded by a transfer from the Tax Stabilization Reserve.

Upon a motion of Council Member Johnson, seconded by Council Member Oliver, the Ordinance was before the Council for its consideration. Motion prevailed. Council Member Johnson spoke on the purpose of the Ordinance and made comments. Council Member Oliver requested to be added as a co-sponsor and made comments. Council Member McCoy made comments. Council Member Johnson made closing comments.

President Congo requested the Clerk to call for the roll.

The above-referenced Ordinance was read for the third and final time and was adopted by title and section recurring to the Enacting Clause and was passed by the following Yea and Nay Roll Call Vote: Yeas, Council Members White, Darby, Oliver, Harlee, B. Fields, McCoy, Johnson, N. Field, Cabrera, Mills, Spadola and Bracy, and Council President Congo. Total, thirteen. Nays, none.

President Congo declared the Ordinance adopted.

Council Member Darby presented <u>Resolution No. 24-001</u> (Agenda #0377) as follows:

WHEREAS, on July 27, 2022, Governor John C. Carney, Jr. signed Delaware House Bill 422 into law, which amended Wilm. C. (Charter) § 3-304(b) to grant the City the authority to determine the residency requirements for its non-elected employees; and

WHEREAS, initial discussions between the Administration and City Council regarding the parameters of the City's residency requirement broke down; and WHEREAS, in response, the Administration unilaterally determined that House Bill 422 removed the residency requirement altogether; and

WHEREAS, on October 19, 2023, Councilmember Al Mills was set to call for the third and final reading of Revision 2 to Substitute 1 to Ordinance No. 22-035 which, if passed and signed, would remove the City's residency requirement; and

WHEREAS, there was an outpouring of opposition, resulting in almost three hours of public comment against the residency rescission; and

**WHEREAS**, on October 27, 2023, Council introduced Ordinance 23-040, which established a five-year residency requirement; and

**WHEREAS**, Council considered Revision 2 to Substitute 2 to Ordinance 23-040 for third and final reading on November 16, 2023; and

WHEREAS, there was full support for this legislation. Again, there was over three hours of public comment, this time supporting the residency requirement; and

WHEREAS, City Council passed Revision to Substitute 2 to Ordinance 23-040, and submitted it to Mayor Michael S. Purzycki, as Wilm. C. (Charter) § 2-202 requires; and

WHEREAS, the Mayor neither signed nor vetoed the bill. Instead, he allowed it to become law; and

**WHEREAS**, in his non-signing statement, the Mayor denigrated his constituents, calling their First Amendment expression "mob rule"; and

WHEREAS, it is inaccurate to call fervent First Amendment advocacy "mob rule"; and

**WHEREAS**, it is unbecoming for the Mayor to rebuke his constituents in such a manner.

WHEREAS, it is in this spirit that the City Council feels compelled to call out the Mayor's unprofessional behavior.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that Council expresses a vote of no confidence in Mayor Michael S. Purzycki for his comments regarding duly passed legislation.

**BE IT FURTHER RESOLVED** that Council urges the Administration to work with Council to find compromises when considering controversial legislation.

Upon a motion of Council Member Darby, seconded by President Congo, the Resolution was before the Council for its consideration. Motion prevailed. Council Member Darby spoke on the purpose of the Resolution and made comments. Council Members Johnson, Oliver, McCoy, B. Fields, and Harlee made comments. President Congo made comments. Total, two. Nays, Council Members White, Oliver, Harlee, B. Fields, McCoy, Johnson, N. Field, Cabrera, Mills, Spadola, and Bracy. Total, eleven.

President Congo declared the Resolution defeated.

President Congo declared the Resolution adopted.

On behalf of President Congo, Council Member Harlee presented Resolution No. 24-004 (Agenda #0380) as follows:

WHEREAS, a City Council Taskforce to Study and Develop Reparation Proposals for African Americans, with a Special Consideration for African Americans Who are Descendants of Persons Enslaved in the United States (hereinafter the "Taskforce"), was established by Resolution No. 20-080 as amended, and its timeline modified by Resolution No. 23-050; and

WHEREAS, the members of the Taskforce are responsible for making findings and recommendations to City Council regarding issues of systemic racial disparity, racist practices and procedures, and/or institutional discrimination against African Americans, resulting from the delivery or provision of City government services or the implementation or effect of City policies, and resulting from the delivery or provision of other government-provided services or widely implemented business practices or the implementation or effect of government policies or business practices; and

WHEREAS, Resolution No. 20-080 as amended resolved that the Taskforce findings and recommendations be submitted to the Wilmington City Council "within 180 days of its [the Taskforce's] appointment," or July 2023; and

WHEREAS, Resolution No. 23-050 modified the Taskforce's allowable timeline for meetings to correspond with the date when the members held their first open meeting on July 10, 2023, to accommodate its transition to full compliance with the conventions of the Freedom of Information Act (FOIA) regarding public bodies established by Chapter 100, Title 29 of the Delaware State Code; and

WHEREAS, the Taskforce has held public meetings to confer on this matter, to consult with experts knowledgeable about past and present racial inequities experienced by the residents of the City of Wilmington, and to provide the public with opportunities to comment on the work of the Taskforce at each meeting session; and

**WHEREAS**, the Taskforce has requested additional time to synthesize their findings and recommendations into a report for presentation to the Council of the City of Wilmington.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that this Legislative body approves the request of the City Council Taskforce to Study and Develop Reparation Proposals for African Americans, with a Special Consideration for African Americans Who are Descendants of Persons Enslaved in the United States, or the "Taskforce," to finalize and submit a report containing findings and recommendations no later than March 31, 2024.

**BE IT FURTHER RESOLVED** that any additional meetings or public forums by the Taskforce will be in furtherance of formulating recommendations for the final report.

Upon a motion of Council Member Harlee, seconded by Council Members White and Bracy, the Resolution was before the Council for its consideration. Motion

prevailed. Council Member Harlee spoke on the purpose of the Resolution and made comments.

President Congo requested the Clerk to call for the roll.

WHEREAS, the matching funds will be provided by already budgeted funds; and

WHEREAS, City Council deems it necessary and appropriate to authorize the grant application for the aforesaid purpose.
