FISCAL IMPACT STATEMENT: This Ordinance has no anticipated fiscal impact.

AN ORDINANCE TO AMEND CHAPTER 44 OF THE CITY CODE TO INCREASE THE INCOME THRESHOLD FOR THE EXEMPTION OF CAREGIVER, ELDERLY, OR DISABLED PERSONS FROM REAL ESTATE TAXATION

FISCAL IMPACT STATEMENT: This Ordinance's fiscal impact is unknown at this time.

President Congo declared the Floor Amendment adopted.

The Ordinance, As Amended, was before the Council for its consideration. Council Member McCoy spoke on the Ordinance, As Amended. Council Member Bracy requested to be added as a co-sponsor. Council Member Spadola made comments and raised a question, and Council Member McCoy responded and made comments. Council Member Johnson made comments. Council Member White raised questions, and Council Member McCoy responded. Council Member White made comments. Council Member Harlee made comments. Council Member B. Fields raised a question and made comments. Council Member Cabrera made comments. Council Member Bracy made comments and raised a question, and Council Member McCoy responded. The above-referenced Ordinance, As Amended, was read for the third and final time and was defeated by the following Yea and Nay Roll Call Vote: Yeas, Council Members B. Fields, McCoy, N. Field and Bracy, and Council President Congo. Total, five. Nays, Council Members Johnson, Cabrera and Spadola. Total, three. Present, Council Members White and Harlee. Total, two. Absent, Council Members Darby, Oliver and Mills. Total, three.

President Congo declared the Ordinance, As Amended, defeated.

Note: At this time, Council Members N. Field and McCoy requested to be excused from the meeting.

Council Member Cabrera presented <u>Resolution No. 24-069</u> (Agenda #0517) as follows:

WHEREAS, the City of Wilmington (the "City") is an "Entitlement Community" for purposes of the Community Development Block Grant Program (the "CDBG Program"), the HOME Investment Partnerships Program (the "HOME Program"), the Emergency Solutions Grant Program (the "ESG Program"), and the Housing Opportunities for Persons With AIDS Program (the "HOPWA Program"); and

WHEREAS, the United States Department of Housing and Urban Development ("HUD") regulations require a consolidated application process for funds for the CDBG Program, the HOME Program, the ESG Program, and the HOPWA Program; and

WHEREAS, on May 18, 2023, City Council adopted Resolution 23-022, which approved the City's annual action plan for City fiscal year 2024/federal fiscal year 2023 (the "CFY24/FFY23 Plan") and authorized the Mayor to submit it to HUD; and

WHEREAS, on October 19, 2023, City Council adopted Resolution 23-064, which approved the first substantial amendment to the CFY24/FFY23 Plan and authorized the Mayor to submit it to HUD; and

WHEREAS, on October 3, 2024, City Council adopted Resolution 24-057, which approved the second substantial amendment to the CFY24/FFY23 Plan and authorized the Mayor to submit it to HUD; and

WHEREAS, the City has prepared a third substantial amendment to the CFY24/FFY23 Plan (the "Substantial Amendment"), which provides for the following revisions to the CFY24/FFY23 Plan: (i) deletes the CDBG street improvement project and delivery costs funded for the streets near the Villa Maria project until a later date when the project is closer to implementation; (ii) terminates the CDBG Code Repair Program; (iii) reduces the CDBG Home Repair Program Delivery by \$130,000; and (iv) adds \$450,000 in reallocated CDBG funds to the New Castle County Lead-Hazard and Healthy Homes program; and

WHEREAS, a copy of the amended and restated CFY24/FFY23 Plan, which incorporates the Substantial Amendment, is attached hereto and incorporated herein as Attachment "A" (the "Amended and Restated CFY24/FFY23 Plan"); and

WHEREAS, City Council's Community Development and Urban Planning Committee and the Mayor's Office have reached a consensus with respect to specific categories of spending and the amount of funds to be allocated to each such category in the Substantial Amendment; and

WHEREAS, the referenced HUD regulations require that certain public participation requirements must be satisfied regarding proposed substantial amendments to Consolidated Plans, and the City has met such requirements with respect to the Substantial Amendment.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE

CITY OF WILMINGTON that Mayor Michael S. Purzycki, or his designee, is hereby authorized to submit the Substantial Amendment to HUD, which provides for the following revisions to the CFY24/FFY23 Plan: (i) deletes the CDBG street improvement project and delivery costs funded for the streets near the Villa Maria project until a later date when the project is closer to implementation; (ii) terminates the CDBG Code Repair Program; (iii) reduces the CDBG Home Repair Program Delivery by \$130,000; and (iv) adds \$450,000 in reallocated CDBG funds to the New Castle County Lead-Hazard and Healthy Homes program.

BE IT FURTHER RESOLVED that City Council hereby endorses the specific enumeration of categories and amounts set forth in the Amended and Restated CFY24/FFY23 Plan, a copy of which is attached hereto as Attachment "A" and made a part hereof, and so endorses said enumeration, with the understanding that the Mayor's Office will expend funds and administer the funding program in a manner consistent with said enumeration and will review substantial changes, as defined by the Consolidated Plan regulations, in the enumeration of categories and amounts with the Community Development and Urban Planning Committee of City Council prior to the implementation of any such changes.

BE IT FURTHER RESOLVED that Mayor Michael S. Purzycki, or his designee, is hereby authorized to execute and submit the Substantial Amendment to HUD and he, or his designee, is hereby further authorized to certify to such matters as the Secretary of HUD may require with the application, to provide additional information as may be required, and to administer and expend such funds as are received or become available in accordance with the Consolidated Plan regulations and the regulations governing the CDBG Program, the HOME Program, the ESG Program, and the HOPWA Program.

Fields, Johnson, Cabrera, Spadola and Bracy, and Council President Congo. Total, eight. Nays, none. Absent, Council Members Darby, Oliver, McCoy, N. Fields and Mills. Total, five.

President Congo declared the Resolution adopted.

Council Member Cabrera presented <u>Resolution No. 24-070</u> (Agenda #0518) as follows:

WHEREAS, the City of Wilmington (the "City") is an "Entitlement Community" for purposes of the Community Development Block Grant Program (the "CDBG Program"), the HOME Investment Partnerships Program (the "HOME Program"), the Emergency Solutions Grant Program (the "ESG Program"), and the Housing Opportunities for Persons With AIDS Program (the "HOPWA Program"); and

WHEREAS, the United States Department of Housing and Urban Development ("HUD") regulations require a consolidated application process for funds for the CDBG Program, the HOME Program, the ESG Program, and the HOPWA Program; and

WHEREAS, on June 6, 2024, City Council adopted Resolution 24-029, which approved the City's annual action plan for City fiscal year 2025/federal fiscal year 2024 (the "CFY25/FFY24 Plan") and authorized the Mayor to submit it to HUD; and

WHEREAS, the City has prepared a first substantial amendment to the CFY24/FFY23 Plan (the "Substantial Amendment"), which provides for the following revisions to the CFY25/FFY24 Plan: (i) deletes the \$15,000 CDBG grant to the Delaware Center for Horticulture ("DCH") for its Branches to Chances Re-Entry Program because DCH declined the grant and (ii) adds a \$15,000 CDBG grant to the YWCA Delaware (Home Life Management Center) ("YWCA") for the YWCA's homeless shelters for victims of domestic violence; and

WHEREAS, a copy of the amended and restated CFY25/FFY24 Plan, which incorporates the Substantial Amendment, is attached hereto and incorporated herein as Attachment "A" (the "Amended and Restated CFY25/FFY24 Plan"); and

WHEREAS, City Council's Community Development and Urban Planning Committee and the Mayor's Office have reached a consensus with respect to specific categories of spending and the amount of funds to be allocated to each such category in the Substantial Amendment; and

WHEREAS, the referenced HUD regulations require that certain public participation requirements must be satisfied regarding proposed substantial amendments to Consolidated Plans, and the City has met such requirements with respect to the Substantial Amendment.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE

CITY OF WILMINGTON that Mayor Michael S. Purzycki, or his designee, is hereby authorized to submit the Substantial Amendment to HUD, which provides for the following revisions to the CFY25/FFY24 Plan: (i) deletes the \$15,000 CDBG grant to the DCH for its Branches to Chances Re-Entry Program because DCH declined the grant and (ii) adds a \$15,000 CDBG grant to the YWCA for its homeless shelters for victims of domestic violence.

BE IT FURTHER RESOLVED that City Council hereby endorses the specific enumeration of categories and amounts set forth in the Amended and Restated CFY25/FFY24 Plan, a copy of which is attached hereto as Attachment "A" and made a part hereof, and so endorses said enumeration, with the understanding that the Mayor's Office will expend funds and administer the funding program in a manner consistent with said enumeration and will review substantial changes, as defined by the Consolidated Plan regulations, in the enumeration of categories and amounts with the Community Development and Urban Planning Committee of City Council prior to the implementation of any such changes.

BE IT FURTHER RESOLVED that Mayor Michael S. Purzycki, or his designee, is hereby authorized to execute and submit the Substantial Amendment to HUD and he, or his designee, is hereby further authorized to certify to such matters as the Secretary of HUD may require with the application, to provide additional information as may be required, and to administer and expend such funds as are received or become available in accordance with the Consolidated Plan regulations and the regulations governing the CDBG Program, the HOME Program, the ESG Program, and the HOPWA Program.
