Council Member Oliver WHEREAS, pursuant to Section 2-308 and Section 8-200 of the City Charter, the City of Wilmington is authorized to enter into contracts for the supply of personal property or the rendering of services for a period of more than one year if approved by City Council by ordinance; and

WHEREAS, the City entered into a five-year professional services agreement with Itron, Inc. ("Itron") for mobile automated meter reading operations and systems maintenance for the period from July 1, 2015 through June 30, 2020 (the "Agreement"), a copy of which is available for review in the Department of Public Works; and

**WHEREAS**, the City and Itron entered into a five-year extension of the Agreement for the period from July 1, 2020 through June 30, 2025, which was approved by City Council via Ordinance No. 20-027; and

WHEREAS, the City and Itron would like to further extend the Agreement for an additional period of three (3) years at the estimated price not to exceed Four Hundred Fifty Thousand Dollars (\$450,000.00) per year, as set forth in the change order (the "Amendment"), a copy of which, in substantial form, is attached hereto and incorporated by reference herein as Exhibit "A"; and

WHEREAS, it is the recommendation of the Department of Public Works that City Council authorize the City to enter into the Amendment to extend the Agreement for three (3) years; and

WHEREAS, City Council deems it necessary and appropriate to authorize the City to enter into the Amendment to extend the Agreement for three (3) years.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF WILMINGTON **HEREBY ORDAINS:** 

**SECTION 1.** The Amendment to the Agreement (being the professional services agreement with Itron for mobile automated meter reading operations and systems maintenance) to extend the Agreement for the period of three (3) years, a copy of which, in substantial form, is attached hereto and incorporated by reference herein as Exhibit "A", at an estimated price not to exceed Four Hundred Fifty Thousand Dollars (\$450,000.00) per year, is hereby approved, and the Mayor, or his designee, is hereby authorized to execute the Amendment, as well as to take all additional undertakings related thereto as may be necessary.

**SECTION 2.** This Ordinance shall become effective upon its passage by City Council and approval by the Mayor.

The word "reasonable" is inserted prior to "attorney's fees" in the last sentence of Section 8.2.

- A new Section 9.3 is hereby added to the Agreement as follows:
  - 9.3 <u>Termination for Convenience</u>. Customer may terminate this Agreement for convenience with thirty (30) days' advance written notice to Itron. In the event of such a termination, Customer shall pay Itron any fees then due for Services performed by Itron through the effective date of termination, if such Services have been performed as specified in this Agreement, and Itron shall deliver to Customer any deliverables, reports, or other documents related to such Services.
- Section 10.2 is hereby amended to change the name of the Customer's contact from "Jeff Starkey, Commissioner" to "Kelly Williams, Commissioner".
- Section 10.7 is hereby amended as follows:

The phrase "the State of Delaware" in the last sentence of Section 10.7 is hereby struck and the phrase "New Castle County, Delaware" is hereby inserted in its place.

- A new Section 10.13 is hereby added to the Agreement as follows:
  - 10.13. <u>Discrimination and Harassment</u>. In the performance of this Agreement, the parties agree that they shall not discriminate or harass, or permit discrimination or harassment, against any person because of age, sex, marital status, race, religion, color, national origin, or sexual orientation.
- A new Section 10.14 is hereby added to the Agreement as follows:
  - 10.14. <u>Business License</u>. Itron shall obtain and/or maintain an appropriate business license from the City of Wilmington Department of Finance.
