WHEREAS, Wilmington City Council (“City Council”) enacted the provisions set forth in Chapter 2, Article V, Division 6 of the City Code constituting the City Ethics Requirements (the “Ethics Requirements”), with the provisions thereof paralleling the provisions of the State Employees’, Officers’ and Officials’ Code of Conduct set forth in 29 *Del. C.* Ch. 58; and

WHEREAS, Section 2-343(a) of the Ethics Requirements establishes the Wilmington Ethics Commission (the “Commission”) and provides that it shall “consist of seven members appointed by the Mayor with the concurrence by resolution of a majority of all members of council”; and

WHEREAS, Section 2-343(b) of the Ethics Requirements provides that each member of the Commission is appointed for a term of four years beginning on the day of such appointment and lasting until the member’s successor has been appointed and has qualified; and

WHEREAS, Section 2-343(b) of the Ethics Requirements states that no member of the Commission may serve for more than two full four-year terms; and

WHEREAS, William D. Johnston, Katherine Klocko, and Faith Meisinger-Petit were reappointed to the Commission to serve their second full four-year terms beginning on September 16, 2021; and

WHEREAS, Mayor John Carney has appointed Michael Reilly, Cathy Scott Halloway, and Greg Luna to each serve a four-year term on the Commission replacing William D. Johnston, Katherine Klocko, and Faith Meisinger-Petit, respectively; and

WHEREAS, the Ethics Requirements prohibiting (i) more than four members of the Commission from being registered with the same political party and (ii) any member from

holding any elected, appointed, or political party or campaign office are satisfied with the proposed appointments; and

WHEREAS, City Council deems it necessary and appropriate to express its concurrence in the appointments of Michael Reilly, Cathy Scott Halloway, and Greg Luna to the Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Council hereby expresses its concurrence with the appointment by Mayor John Carney of Michael Reilly, Cathy Scott Halloway, and Greg Luna to the Commission to each serve a four-year term beginning on the date of passage of this Resolution.
