#0203 An Ordinance Establishing a Rate of Taxation on Real Property and the Taxable Property of Public Utilities for the Fiscal Year Beginning on July 1, 2026 and Ending on June 30, 2027 **(1st & 2nd Reading)**

This Ordinance sets the property tax rate for Fiscal Year 2027 (July 1, 2026 - June 30, 2027) based on the certification by the Board of Assessment of the assessed valuation of taxable real property in the City and the Mayor’s estimates of revenue measures necessary to balance the City budget as required by the City Charter.*
