Enforcement

OMC is NOT enforcement. OMC is only responsible for the regulations process that licenses the growers, manufacturers, retailers, and testing facilities. DATE established the Marijuana Task Force, which is responsible for enforcement.




WHAT'S IN MY TOWN

- Developing “Illicit Market”
- 2018 Farm Bill unintentionally created this market
- 0.3% THC limit Dry weight
- Unregulated after cultivation
- Intoxicating hemp products
- Hemp Based THC infused Products
- Delta 8 THC synthesized from CBD
- $\text{CBD} + \text{ACID} + \text{HEAT} = \text{DELTA-8 THC}$






DATE CASES

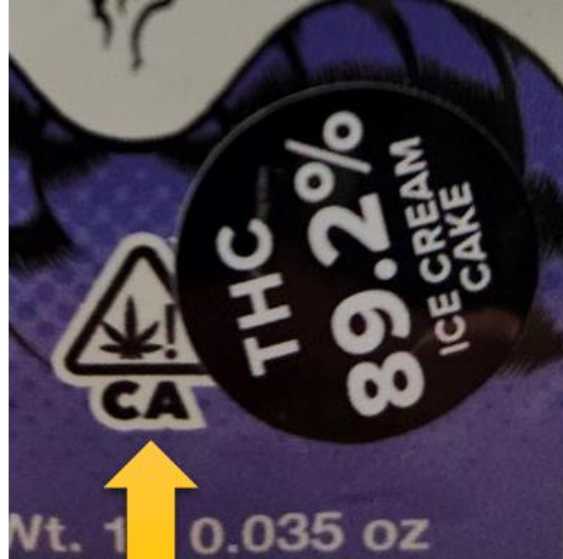
- Complaints received via DATE Tip Line of businesses selling THC products or selling to underage
 - DATE Self-Initiated Investigations (Inspections),
 - DATE has been assisting Law Enforcement Agencies with testing THC products seized during investigations.
 - DATE has been conducting their own investigations into businesses selling THC products.
 - Tobacco Stores & Convenience Stores are selling Marijuana and/or Hemp Derived Products (Delta 8, Delta 10, THCA). Stores are claiming that their products are compliant with the Farm Bill. The Farm Bill states “hemp-derived products containing a concentration of up to 0.3% THC are not controlled substances”.

DATE FIELD WORK

- DATE has conducted direct buys at these businesses selling Marijuana products.
 - The products that are purchased through a direct buy are tested two different ways.
 - 1 – DATE Light Lab
 - 2 – Medical Examiner Office or High Tide Lab Company
 - Cease and Desist and Future of Investigation
 - If a direct buy is made and the product tests over the 0.3% a DAG approved Cease and Desist letter is mailed and hand Delivered by DATE.
 - The business is given (2) weeks to comply with the C&D. After (2) weeks a second direct buy is attempted.
