WHEREAS, pursuant to Section 2-363 of the City Code, City Council deemed it necessary and proper to specify the requirements for review and approval of City-sponsored grant applications and proposals, including authorization for expedited grant applications when necessary prior to Council's approval by resolution; and

WHEREAS, the Department of Parks and Recreation has submitted a grant application to the State of Delaware Department of Services for Children, Youth & Their Families (DSCYF) in the amount of \$328,987.59; and

WHEREAS, the grant funding will be used to reimburse the City for the costs associated with implementing a Citywide Out-of-School Time program designed to provide safe, structured, and enriching environments for youth during high-risk out-of-school hours, particularly between 3:00 p.m. and 7:00 p.m.; and

WHEREAS, the Out-of-School Time program will be conducted at the William "Hicks" Anderson Community Center, the Community Education Building Youth Development Center, the MSK Community Center, and the Police Athletic League Wilmington, will serve approximately 150-200 youths, and will run Monday through Friday and two Saturdays a month from the beginning of September 2026 through mid-June 2027; and

WHEREAS, no matching funds are required; and

WHEREAS, City Council deems it necessary and proper to authorize the grant application for the aforesaid purposes.

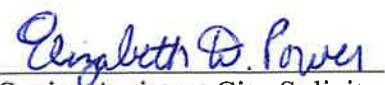
NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON that the Department of Parks and Recreation's grant application to the to the State of Delaware Department of Services for Children, Youth & Their Families (DSCYF) in the total amount of \$328,987.59, or such other amount that the DSCYF awards, is hereby authorized.

BE IT FURTHER RESOLVED that the Director of the Department of Parks and Recreation, or her designee, shall be authorized to take all necessary actions to accept any and all funds associated with the grant application and to fulfill the grant requirements.

SYNOPSIS: This Resolution authorizes the Department of Parks and Recreation's grant application to the State of Delaware Department of Services for Children, Youth & Their Families (DSCYF) in the amount of \$328,987.59, or such other amount that the DSCYF awards. The grant funds will be used to reimburse the City for the costs associated with implementing a Citywide Out-of-School Time program designed to provide safe, structured, and enriching environments for youth during high-risk out-of-school hours for the 2026-2027 school year. No local matching funds are required.

FISCAL IMPACT STATEMENT: The Office of Management and Budget has reviewed and analyzed this Resolution, which authorizes the Department of Parks and Recreation to apply for and accept grant funding from the DSCYF in the amount of \$328,987.59, or such other amount as the DSCYF awards, to reimburse the City for costs associated with implementing the Citywide Out-of-School Time program for the 2026-2027 school year. This grant does not require City matching funds and is not expected to result in a net additional General Fund cost, as long as program costs are eligible for reimbursement and do not exceed the final grant award. Because the grant reimburses the City after costs are paid, the City will need to pay program expenses first using available General Fund cash and then request reimbursement from the grant. This creates a cash-flow timing issue, but not a new City cost, unless costs are later found to be ineligible for reimbursement or exceed the amount awarded. Any such costs would need to be paid from another authorized funding source.
